PC Dibb reported that Inspector A. Winter retired later this month and would be replaced by Inspector A. Cartwright, who had worked in Pendle as a Sergeant and was familiar with the area.

In terms of staffing, a request from Lancashire's Police and Crime Commission for additional funding had been raised from a Council Tax precept increase which would fund a 40-strong neighbourhood policing task force. Initially 4 officers would work in Pendle and the Ribble Valley, managed by Sgt Boast. They would work as a team and tasked to deal with specific problem areas. If need be, all 40 officers could be brought in to work on particular operations. Their shift patterns could also be changed depending on the work required.

In the last few days there had been a spate of daytime burglaries in the area from masked men gaining entrance by smashing patio doors, including a couple of properties in Barrowford. It was thought that they had travelled from the Yorkshire area and were working their way over to the Ribble Valley. The Police were following some leads on a vehicle which could link it to the crimes.

PC Dibb said he would speak to the developers at Clough Springs, Wheatley Lane Road about their workers parking their vehicles more considerately whilst the traffic signals were in place.

## 31. COMMUNITY INVESTMENT FUND

Members noted the allocations made from the Community Investment Fund detailed on the agenda.

## 32. RESIDENTS-ONLY PARKING ON FOREST VIEW, BARROWFORD

A petition had been received from residents of Forest View, Barrowford seeking to make the angled parking spaces behind Forest View, Barrowford for residents only. The land in question was privately owned. Lancashire County Council had said they would need to undertake a survey to provide evidence to confirm it met their criteria. LCC would also need an assurance that the land owner agreed to the parking controls being placed, for charges to be applied to residents and enforcement undertaken. It was estimated that the costs of the Traffic Regulation Order, the signs and lines would be in the region of £4,000.

#### **RESOLVED**

That the Housing, Health and Engineering Services Manager be asked to request Lancashire County Council to undertake the necessary survey for residents only parking on the angled parking spaces behind Forest View, Barrowford.

#### REASON

To try to ease parking for local residents.

# 33. HIGHWAYS SAFETY ISSUES ON SANDY LANE, BARROWFORD

A local businessman had complained about inconsiderate parking on Sandy Lane which was causing obstructions and problems for other highway users. There were also reports of near collisions at the junction of Nora Street/Sandy Lane/Gisburn Road. Members discussed the various highways issues in this busy location and agreed that improvements such as better signage and introducing a "no right turn" when exiting Sandy Lane onto Nora Street/Gisburn Road might be beneficial.

#### **RESOLVED**

That Lancashire County Council be asked to undertake a site visit to look at possible solutions for improving road safety at the junction of Nora Street/Sandy Lane/Gisburn Road.

## REASON

In the interests of highway safety.

## 34. PROBLEM SITES

The Planning, Economic Development and Regulatory Services Manager submitted a report on problem sites in Barrowford and the Western Parishes. It was noted that work was expected to start shortly at Spen Brook Mill.

Residents of Higherford were beginning to complain again about the state of the Corn Mill, which had been on the problem sites list for many years, but had been removed last year, when it was felt that all possible action had been undertaken to improve the property. Members agreed that the physical appearance of the site continued to deteriorate and was unsightly.

## **RESOLVED**

That Policy and Resources Committee be asked to consider the compulsory purchase of the Corn Mill in Higherford and in the meantime, that the site be put back on the problem site list and the Planning, Economic Development and Regulatory Services Manager be asked for an update on any discussions he had had with the owner regarding possible planning applications.

## REASON

In the interests of visual and residential amenity.

## 35. ENVIRONMENTAL BLIGHT

The Housing, Health and Engineering Services Manager submitted a report on environmental blight sites in Barrowford and the Western Parishes. It was noted that whilst some work had been done to cut back the shrubs on the garage site at the junction of Nora Street and Higher Causeway, the site still looked overgrown and foliage from the trees was encroaching onto the footpath.
