To increase over a two year period the subscription fee for the collection of Garden Waste to support the delivery of the collection service.

### 7. IMPACT ON SERVICE PROVISION, IMPLEMENTATION AND OTHER ISSUES

Following investigation into the benefits of promoting an 'earlybird' incentive scheme for Garden waste subscriptions we have identified that in most of the past subscription years the Council has received over 40% of the total income prior to the 31<sup>st</sup> May.

Information below shows a breakdown of the payments from introduction of the garden waste subscription fee in 2014 through to the current subscription year which we are still receiving subscriptions too.

Based on the above it is felt that the introduction of an early bird subscription scheme used to encourage new or early payment could potentially create a negative impact on the garden waste collection scheme.

The proposal put forward is to increase garden waste subscriptions in 2020/20121 to £33.00 without any early bird incentives.

The proposal is then to increase subscription fees by a further £2.00 to £35 in 2021/2022.

The figures below compare potential levels of income based on 5600 subscribers taking up the early bird offer and 3040 subscribers choosing not to.

The figure of 8640 is based on the 2018/2019 subscriptions.

With early bird:  $5600 \times £32 = £179,200 \text{ plus } 3040 \times £35 = £106,400, \text{ total} = £285,600$ 

Year 1. Without early bird: 8640 x £33 = £285,120

Year 2.  $8640 \times £35 = £302,400$
