3. Pennine Lancashire Healthy Weight Programmes: Healthy Weight Declaration

The Panel is reminded that Pennine Lancashire is one of five national Trailblazer areas to tackle childhood obesity and is also one of 12 Sport England Local Delivery Pilot areas which aims to increase physical activity across the patch.

Enc. To support the delivery of both these programmes, the Council has signed the Healthy Weight Declaration and approved the District Action Plan (both attached).

A group consisting of Councillors across the Borough has been established to work towards ensuring that healthy weight is embedded into all decision making across the Council and to play a key role in championing and promoting the importance of healthy weight at a local level.
