# 1. Welcomes and Apologies

# 3. Matters Arising

Police Actions:

- Cannabis Waste dumping across Colne District – update: Incidents continue to be reported, despite the closing of two cannabis farms in Colne and Nelson and the seizure of 500 plants.

Update on drug actions

Cllr. Mann reported that young people taking and dealing drugs by The Arches has lessened since the Police put this area on their regular patrol plan. The Police reported no sightings.

Off-lead Lurchers actions

The owners of the lurchers have moved and no one knows where.

Actions on Derby Rd speeding

This was reported to be continuing and children play in the street. The resident would like to see warning signage being erected. This matter was raised at January's meeting, so PC Cleal agreed to raise it with PC Lunney.

Cllr Foxley – Trawden Schools actions:

The Chair agreed to contact Cllr Foxley for an update. PC Lunney has visited the school intermittently and has had no complaints since Christmas.

#### Chair's Actions:

- Ball Grove lower gate Friends of Ball Grove state that there is no agreement to leave the gate locked open during daylight and this is a contravention of the agreement with the residents. The Chair has learnt that this issue is one that must be satisfactorily addressed before Ball Grove Park is transferred to Trawden Parish Council.
- Littered footpath Pendle Vale PBC litter team actioning a clear-up.
  The Chair has chivvied Pendle Borough Council's Environmental Crimes Unit and has suggested a range of actions to tackle this problem with various stakeholders.

Cllr Cockburn-Price – abandoned vehicles Hartley St and Sefton St, and illegal use of vehicle Sefton St area. She has contacted the original complainant to see if the problem has been dealt with. The telephone number for reporting abandoned vehicle is: 01282 661743. Tim Horsley agreed to follow this up with Police help, especially as the trailer is blocking the back street.

#### 4. Matters of Concern

**JS** – Persistent fly-tipping in the yard at the rear of the Hospice Shop in Dockray St is creating a serious risk to shoppers and staff because it blocks the fire exit. Action has been taken to alert the Hospice, PBC and a suggestion that the landlord install CCTV to try and detect the repeat offenders. The latest event took place between Saturday evening and Monday morning 8-15. (Update – Waste sourced to a departing tenant from flat -above the Hospice shop. Waste to be removed Wednesday 12<sup>th</sup> Feb.)

Cllr. Pat Howarth – cars are travelling up Walton Street too fast. She has witnessed three near accidents in the last six weeks. There is a need for white lining across Seldon Street. The Chair agreed to chase this up with LCC.

Cllr. Alice Mann – The Greenfield Arts Centre (has CCTV) has suffered lads entering and causing trouble. A bike and wheelchair have been stolen. There were three lads involved and two were remorseful.

John Barker – Children have been winding up both residents and dogs in Derby Street. In addition, cars are going up the on-way system the wrong way. PC Hartley and Simon Bucknell are aware of this. Additional signage is needed.

In absentia, Cllr Mcnulty commented – There is drug dealing at the top of Briercliffe Ave. and they are meeting up at Hereford Road on a daily basis. The advice from the Police was to call PC Cleal the moment this is observed.
