**7. APPLICATION FOR A PREMISES LICENCE – COLNE CRICKET AND BOWLING CLUB,

The Planning, Economic Development and Regulatory Services Manager submitted a report which asked members to consider an application for a Premises Licence following receipt of representations from local residents.

The application was from Colne Cricket and Bowling Club of The Horsfield, Bryon Road, Colne. The contact for the application was Mr Paul White and the proposed designated premises supervisor (DPS) for the licence was Mr. Geoff Marsden.

The Members and all relevant parties had received a copy of the report which included a copy of

the application and the representations received.

Mr. M. Armfield (Licensing Enforcement Officer), Mrs. J. Dickinson and Mr. M. Duck (Environmental Health Officers) and Mr. White and Mr. Marsden for Colne Cricket and Bowling Club and 7 objectors attended the hearing.

## **RESOLVED**

That having listened to the representations made the Premises Licence be granted with the following conditions:-

- (1) That the windows and doors of the Pavilion and Tea Room to be kept closed.
- (2) That a noise limiter be installed in the Pavilion and Tea Room.
- (3) The playing of live or recorded music outdoors at the 6 notifiable events to cease at 10pm.
- (4) The sale of alcohol to be limited to the Pavilion and the Tea Room.
- (5) That conditions previously agreed with the Responsible Authorities, which were further detailed in the report be attached to the Licence.
