# TRAFFIC LIAISON MEETING

The minutes of the Traffic Liaison meeting held on 9<sup>th</sup> September, 2020 were submitted for information.

A discussion was held regarding the traffic lights at the junction of Langroyd Road and North Valley Road, Colne. It was understood that the timing of the lights had been tuned to improve traffic flow. It was agreed that this in itself was not deemed to be a problem, however the short light time at this junction often led to vehicles proceeding through a red light.

Although the issue had not recently been discussed at the Traffic Liaison meeting, the Committee was advised that Lancashire County Council had recently approached Colne Town Council to discuss the possibility of linking into the Town Council's CCTV cameras along this route. This had been agreed to and, as a result, the lights could be monitored off-site and adjusted remotely.

However, Members felt that this may not address the problem of vehicles dangerously proceeding through a red light, as the cameras could fail to record this information.

# RESOLVED

That, in view of the frequency of vehicles proceeding through a red traffic light at the Langroyd

Colne and District Committee (08.10.2020)

Road/North Valley Road junction and the danger this presents, the Traffic Liaison Group be requested to consider what action could be taken to address this problem.

# So that this dangerous problem of numerous drivers jumping the lights while on red is satisfactorily tackled.

# 60. TACKLING CONTAMINATION IN RECYCLING BINS

The Environmental Services Manager submitted a report which provided Members with an update on plans to tackle the issue of contamination within the recycling materials collected via household and commercial schemes.

The Committee acknowledged the issues reported and the work being carried out to address the problem. In addition, a number of suggestions were made. These included engagement with primary schools and the use of bin stickers, providing information on what could/could not be placed in the bin.

# TREE PLANTING ON COUNCIL OWNED LAND

Following consideration by the Policy and Resources Committee at its meeting on 17<sup>th</sup> September, 2020, the Committee was invited to comment on a report of the Planning, Economic Development and Regulatory Services Manager. The purpose of the report was to discuss proposals to increase the Council's efforts in planting trees on Council owned land; to inform Committee of funding opportunities; to discuss and propose the need for a Tree and Woodland Strategy for Pendle; and to agree the proposed tree planting annual target.

Appendix 1 to the report provided a list of proposed sites, which included land adjacent to Alkincoats Park; Langroyd sites; and King George V, Colne.

Members suggested a number of other sites that could be suitable for planting, most of which were privately owned. They also felt that there should be some community engagement. The Committee was advised that there was a limited budget and limitations on where the trees could be planted. However, all ideas were welcome and arrangements would be made for the Council's Tree Officer to contact the ward councillors.
