FINANCIAL MATTERS

7. Capital Programme 2020/21

The Housing, Health and Engineering Services Manager reports that the unallocated sum of the Committee's 2020/21 Capital Programme is £16.

On 1 October 2020 it was resolved that £2,000 be granted to Pendle Scouts Club towards an outdoor shelter allowing the beavers, cubs and scouts to meet. Pendle Scouts have since written to the committee to ask if the money allocated could include IT equipment as requested in their original bid. "We will also require provision of IT equipment for members, leaders, volunteers to remain in contact, also facilitating our young people to work towards badges and research/communicate much more efficiently. We would also need to set up internet connection."

MISCELLANEOUS ITEMS

8. Re-opening of Barrowford Town Centre

Cllrs Crossley, Turner and Newman met Andrew Stringer and Robert Oliver of Barrowford Parish Council on 3rd December to discuss how to spend the funds allocated to them for the

re-opening of Barrowford Town Centre. The Economic Development officer also attended and advised what the funds could and couldn't be spent on. They agreed to seek the views of Barrowford businesses on 5th December and met again on 10th Dec to review the situation. A number of ideas were discussed including leaflets promoting the town centre, a website for town centre businesses, and an advert in a local paper. An update on progress and costings will be given at the meeting.

9. Environmental Blight

There are no existing Environmental Blight sites and no new sites have been put forward. The definition of an environmental blight site is:

- Untidy/derelict piece of Council land requiring tidying up and maintaining.
- Untidy/derelict piece of unregistered land requiring tidying up and maintaining.
- Untidy/derelict piece of Council-owned or unregistered land which needs regenerating (eg a former garage colony converted to a landscaped parking area).

New sites should be reported to Tricia Wilson or Julie Whittaker including a contact name and contact details with a brief description of the site and the problem.

10. Exclusion of the public and press
