# Consultation on the Lancashire Local Flood Risk Management Strategy 2021– 2027

#### Introduction

The Flood and Water Management Act 2010 designated Blackburn-with-Darwen Council, Blackpool Council and Lancashire County Council as Lead Local Flood Authorities (LLFAs). The councils have a range of powers, duties and responsibilities and manage flood risk from 'local' sources. These local sources of flooding are surface water, groundwater and ordinary watercourses. The councils want your views on our joint draft Lancashire Local Flood Risk Management Strategy.

Under Section 9 of the Flood and Water Management Act 2010, Lead Local Flood Authorities must produce a Local Flood Risk Management Strategy which is consistent with the <u>National Flood and Coastal Erosion Risk Management Strategy</u> and we must publicly consult on our Draft Strategy.

The aim is to better protect and improve flood resilience for the people of Lancashire. It sets out how we will concentrate our resources and efforts to improve our understanding of local flood risks, whilst delivering schemes, and supporting our businesses and communities.

The strategy and consultation are only intended to address local sources of flooding. The strategy is not concerned with managing flood risk from main rivers, coastal or sewerage sources, because these are covered by the Environment Agency's Plans and Assessments Framework and a national strategy.

### About this consultation

This survey is being undertaken by Infusion Research, part of Blackpool Council's Corporate Development Unit. Data will be gathered in accordance with the Infusion privacy notice accessible from <u>Blackpool Council's website</u>. The strategy describes how the following documents set the context for the strategy: the Flood Risk Regulations 2009, the Flood and Water Management Act 2010; the Town and Country Planning (Development Management Procedure) (England) Order 2015; Land Drainage Act 1991 (as amended by the FWMA 2010); Coast Protection Act 1949 (as amended by FWMA 2010); Highways Act 1980; Climate Change Act 2008; the Water Framework Directive (2000/60/EC); and the Water Industry Act 1991.

- **Riparian owners** – meaning someone who owns land next to or over a watercourse, and must ensure the water can pass freely through their land

- Developers – who manage flood risk on-site as part of a new development

The North West Regional Flood and Coastal Committee ensures there are plans to identify, communicate and manage flood and coastal erosion risks, links to relevant bodies to develop an understanding of flood and erosion risk, and uses this to target investment.

The North West and North Wales Coastal Group examines the economic, social and environmental issues and addresses them through policy.

The Lancashire Flooding and Coastal Erosion Risk Management Partnership supports local governance, ensuring local issues and priorities are reflected at the North West Regional Flood and Coastal Committee. There is a strategic group which sets the overall direction, and a tactical group which reports to the strategic group.

As Lead Local Flood Authorities we work with a number of partner flood risk management authorities as well as wider colleagues from charitable trusts to community groups. The main groups we have identified are:

- **Catchment Partnerships** – which look at practical measures to manage river catchment, and include organisations such as Environment Agency, United Utilities, Local Authorities, Landowners, Wildlife Trusts, National Farmers Union, universities and colleges, and Local Businesses

- Flood Action Groups – around 50 voluntary groups of local residents across the county

- Lancashire Resilience Forum – which pulls together those with a legal duty to respond to emergencies such as the emergency services, local authorities, the NHS, the Environment Agency, United Utilities, Maritime Coastguard Agency and others

# Actions

To deliver our strategy efficiently, effectively, transparently and in a way that is coordinated with our partners and communities we have developed a Business Plan to steer and focus our actions.

A Business Plan is an action-led plan focusing on delivering tasks which meet statutory responsibilities and contribute towards delivering our vision.

Actions identified under Theme 1 (Delivering Effective Flood Risk Management Locally) are:

- To do the work identified in the strategy and keep it up to date

- To review and revise the Flood Investigation Report Policy and the Consenting and Enforcement Policy for regulating Ordinary Watercourses

- To work proactively with Local Planning Authorities to ensure effective local policies are in place for managing flood risk and coastal erosion through the Land and Marine Planning Processes

 To consider the need for a Highway Drainage Connection Policy and a 'Designation of Flood Risk Features' Policy

Consider the need to Manage flood risks created by rivers flowing into the County from neighbouring areas

Actions identified under Theme 2 (Understanding our local risks and challenges) are:

- Deliver any outstanding Surface Water Management Plans (SWMP), and identify further studies needed.

- To bid for funding to install groundwater monitoring equipment in targeted areas in Lancashire; to map all ordinary watercourses in Lancashire, using this to improve risk management; and to improve understanding of opportunities for natural flood management and strategic surface water management across Lancashire through sustainable drainage retrofit.

- To keep the Flood Risk Asset Register up to date
- To map all historic and new known flooding incidents since 2013

- To support development of an 'all source' flooding map for the North West, potentially via the Drainage and Wastewater Management Plan (DWMP)

Actions identified under Theme 3 (Supporting Sustainable Flood Resilient Development) are:

- Work with, support and advise Local Planning Authorities so their evidence base takes account of best practice, climate change, biodiversity net gain and amenity aspirations

- Encourage Local Planning Authorities to adopt the Sustainable Drainage Systems (SuDS) proforma on major developments, link into North West SuDS meetings, and ensure that SuDS assets are captured in Flood Risk Asset Registers

- Explore the feasibility of developing an integrated Lancashire-wide 'SuDS Suitability' guide

- Input on flood and coastal matters into the development of a natural capital accounting / biodiversity net gain approach for Lancashire

- Encourage all flood risk management authorities in Lancashire to become members of the Association of SuDS Authorities (ASA)

We feel that adoption of SuDS by utility companies and Local lead flood authorities should be encouraged similar to the strategy in North Wales.

Actions identified under Theme 4 (Improving Engagement with our Flood Family) are:

- Improve our web presence on flooding and link pages to The Flood Hub, including a new Education section, and sharing Flood Action Group details where they consent to do so

Improve maintenance on assets owned by flood risk management authorities
 Continue pro-active work with partnerships, including Catchment Partnerships with the community and private landowners and attending relevant partnership meetings to share best practice on technical knowledge, operational responses

and infrastructure risks

- Develop a Communication and Engagement Plan showing clear lines of communication and reporting, within and amongst food risk management authorities, wider partners and the people of Lancashire

- Ensure a climate change allowance is incorporated into all proposed new sustainable drainage systems on developments consistent with national and/or local planning requirements and published guidance.

- Investigate the feasibility of introducing SuDS in schools across Lancashire to improve their resilience and provide an educational resource
