**3. Progress on points raised**

**Park View Terrace Salterforth** – Cllr J Purcell has made enquiries with LCC regarding another application request for residents parking. SF to speak to Maggie Isherwood (new Residents Parking Officer, RPO), once in post.

**Skipton Road, Barnoldswick** – MH confirmed that there is an error with the current signage and that this is to be relocated shortly.

**Foster Road, Barnoldswick** – CD has drawn up a new design and this will be sent out for consultation shortly.

**Victory Close Nelson** – This will be reviewed once LCC's RPO in post.

**Langroyd Road Colne** – LCC have rectified the signal faults and all should be working correctly now.

**Lomeshaye Road Nelson** – lines have been remarked and some residents have objected. Therefore the TRO is being reviewed by LCC.

## 5. Parking Concerns / Requests for Restrictions & Signs:

- 5.1 56 Market Street, Colne – Taxi Rank. A request has been made for a taxi rank outside the above property. The land is private and it was agreed that this should not be approved as there is sufficient parking on the rank on the main street.  
**TLM agreed no further action.**
- 5.2 Spring Street, Nelson – Accessing WM Reed Weaving Mill  
The nearby Mill have raised the issue with access again.  
LCC have proposed new signage to advise drivers which street to use for access to the correct gates.  
LCC will look at suitable land to erect the sign on Manchester Road.  
Option 1 sign was approved  
**TLM Approved Signage**
- 5.3 Churchill Way, Brierfield – Experimental Order  
A proposed no waiting 7am to 7pm on Churchill Way has been suggested. This is an Experimental Order to initially see if it's adhered to. If not we will then revoke it and introduce double yellows.  
SW and GM will liaise to arrange cones temporarily.  
**TLM agreed Experimental Order**
- 5.4 Wheatley Lane Road, Fence – NWAAT  
Proposed no waiting near to 359 to 345. Consultation response is in the main positive, but some residents have asked for further restrictions along one side of Wheatley Lane. It was agreed to wait until the end of the consultation and then review to see whether the restriction is to be extended to 329. NWAAT restrictions to be extended to 335 / end of terraces – perhaps alternative north side restrictions as well outside 342-340  
**TLM agree to review following Consultation.**
- 5.5 Gisburn Road Barnoldswick – Redundant School Keep Clear  
A proposal has been made to remove the School Keep Clear at the above location. Whilst there is no longer any demand for the SKC we need to look at an alternative restriction to deter parking. Proposed SYL restriction to match that of the opposite side, this to replace the SKC markings. If SYL doesn't work, then move on to DYL  
  
**TLM agreed Single yellow and keep the area under review.**

## 6. Speed/ Traffic Concerns:

- 6.1 Cotton Tree Lane, Winewall – LCC have received a report about issues with HGV's Accessing the LBS Site.  
**TLM Agreed to agree to liaise with Police and then speak to the company about keeping the HGV's in the yard rather than on the Highway.**
- 6.2 Queen Street, Nelson – Land Grab. A complaint has been received regarding an obstruction on the highways.  
TLM agreed that this would be referred to LCC legal to serve notice and see what can be done to remove the fencing and concrete blocks.
- 6.3 Leeds Road, Nelson – Obstruction on the highway. Pendle BC have received numerous complaints regarding a business at 113 Leeds Rd which regularly blocks the back street to the rear of his business.  
N>B Pendle BC Officers have observed this mainly on a Friday tea time  
**TLM agreed for SW/SF to liaise with GM**

## 7. VIP Enquires

- 7.1 VIP 59845 - Vivary Way, Colne – A report has been received by LCC regarding dangerous driving at Vivary Way at the roundabouts. It's unclear at this point which roundabout this issues refers to.  
**TLM Agreed that MH would confirm with the VIP the location and then refer the issue to Martin Porter at LCC and liaise with GM.**

## 8. Developments

- 8.1 Euro Garages – Greenfield Road, Colne  
KH advised the TLM of the design for access into the new proposed development off Greenfield Road, including a Toucan Crossing. The junction is to be moved slightly and a pedestrian and cycle facilities will be added to allow access for them. TRO is to be reviewed with additional signage to show the restricted access. The Signal Team are to re simulate the controlled junction to check the feasibility for it's relocation.  
**TLM noted the scheme and advised KH to liaise with Martin Porter regarding the lanes off Vivary Way which currently direct both lanes on to the Motorway.**

## 10. LCC HQ items

- 10.1 CN advised the TLM that ParkMap was operational. There is a viewer available called Traffweb for those that don't need the full ParkMap setup.  
Mapzone is still available and should only be one week behind ParkMap in displaying sealed orders.
- 10.2 The new Residents Parking Officer is Maggie Isherwood. Any queries on residents only parking should be referred to the following email – **residentsparking@lancashire.gov.uk**

## 11. Any Other Business

- 11.1 KH asked the group if they were aware that Colne Football are looking for a large refurb with new stands and banqueting area at their Colne site.  
KH raised a concern that there doesn't appear to be any proposed changes for access which is likely to increase traffic...including Coaches  
**TLM agreed that KH to arrange a separate meeting with GM, LCC Matt/Connor and Scott on site to discuss traffic issues**
- 11.2 KH advised of an application for works to Barrowford Reservoir. This is a 2 ½ yr. project with access off Colne Road for improvements to the embankment and to change the water level. There will be a compound in the field and the path around the reservoir will be closed. Temporary lights will be installed to facilitate vehicles, however KH is Suggested that this will need a full access road.  
**TLM agreed to the need for a full access road**
