RESOLVED

REASON

Section 38 of the Planning and Compulsory Purchase Act 2004 requires that applications be determined in accordance with the development plan unless material considerations indicate otherwise. Taking into account all material considerations the proposed development is acceptable in principle. The development therefore complies with the development plan. There is a positive presumption in favour of approving the development and there are no material reasons to object to the application.

21/0479/PIP Permission in Principle: Erection of up to two detached dwellinghouses at Land of the Rear of 145 and 147 Wheatley Lane Road, Barrowford for Mr and Mrs Yates and Mr and Mrs Nelson

(Before the vote was taken, the Planning, Economic Development and Regulatory Services Manager advised that should the application be refused on the grounds proposed there would be a significant risk of costs in the event of an appeal. The matter would therefore be referred to the Head of Legal Services and subject to his agreement the decision would stand referred to the Policy and Resources Committee.)

RECOMMENDATION

That permission be refused on the following grounds -

• Development on this site would cause harm to the Carr Hall and Wheatley Lane Conservation Area.

21/0483/HHO Full: Erection of conservatory to rear at 2 Woodside Cottages, Wheatley Lane Road, Fence for Mr Newman

(Councillor B. Newman declared a pecuniary interest in this item and withdrew from the meeting.)

RESOLVED

That planning permission be granted subject to the following conditions -

- 1. The proposed development hereby permitted shall be begun before the expiration of three years from the date of this permission.
 - **Reason:** Required to be imposed by Section 91 of the Town and Country Planning Act 1990, as amended by Section 51 of the Planning and Compulsory Purchase Act 2004.
- 2. The development hereby permitted shall be carried out in accordance with the following approved plans:

Location Plan: 21/010/2a Elevation Plan: 21/010/1b

Reason: For the avoidance of doubt and in the interests of proper planning.

3. The materials to be used externally on the development hereby authorised shall be as stated on the approved plans and application forms.

Reason: These materials are appropriate for the external appearance in this location and in keeping with other similar developments in the locality.

4. The glazing on the side of the conservatory facing number 1 and number shall at all times be obscure at level 5.

Reason: In order to ensure there is no loss of privacy to the occupants of the adjoining houses.

REASON

Section 38 of the Planning and Compulsory Purchase Act 2004 requires that applications be determined in accordance with the development plan unless material considerations indicate otherwise. The proposed housing development would accord with Local Planning Policy and would be compliant with the guidance set out in the Framework, subject to compliance with planning conditions. The development therefore complies with the development plan. There is a positive presumption in favour of approving the development and there are no material reasons to object to the application.

(b) Planning Appeals

38. PROPOSED REMOVAL OF HACKNEY CARRIAGE RANK ON HALSTEAD LANE/GISBURN ROAD, BARROWFORD

The Planning, Economic Development and Regulatory Services Manager submitted a report considering a request from Lancashire County Council for the removal of the Hackney Carriage rank on Halstead Lane/Gisburn Road, Barrowford.

RESOLVED

That Lancashire County Council be informed that the Council has no objections to the removal of the Hackney Carriage rank on Halstead Lane/Gisburn Road, Barrowford.

REASON

The Hackney Carriage rank has not been utilised by the Hackney Carriage trade since its implementation.

39. RE-OPENING OF BARROWFORD TOWN CENTRE

Members were not clear on how the funding available for the re-opening of Barrowford town centre had been allocated.

RESOLVED

- (1) That the Re-opening the High Streets Safely Fund and the Welcome Back Fund be discussed at the next Full Council meeting of Barrowford Parish Council and any suggestions for spending the funding be fed back to the Economic Development Team.
- (2) That the Planning, Economic Development and Regulatory Services Manager be asked to submit an update to the next meeting.

REASON

To help provide a safe environment for shoppers and traders in Barrowford.

ITEMS FOR DISCUSSION

Parking Problems in Barley

Members discussed a number of issues with residents parking and traffic in Barley including

- Residents of the terraced properties on Pendle View and Beckside, Barley are unable to park their vehicles particularly on evenings and weekends
- Residents becoming increasingly frustrated
- Increased traffic and congestion in the centre of Barley
- Cars parking on the turning circle which was transferred from Pendle Borough Council into Barley with Wheatley Booth Parish ownership in 2015
- Turning circle unable to be used as a passing place or to enable large vehicles to turn
- Three successful businesses contributing to the problems particularly the Barley Mow since it converted its car park into a beer garden

RESOLVED

- (1) That the Housing, Health and Engineering Services Manager be asked to request Lancashire County Council to undertake the necessary survey for residents only parking on Pendle View and Beckside, Barley.
- (2) That the Housing, Health and Engineering Services Manager be asked to report back with any recommendations for easing the problems.
- (3) That Pendle Borough Council work with Barley with Wheatley Booth Parish Council to resolve the turning circle issues.

REASON

To try to improve highway and parking issues in this location for the benefit of residents and visitors.

41. EXCLUSION OF PUBLIC AND PRESS
