At the Council meeting on 31st August members approved the appointment of Graham Cadle as Interim Chief Finance Officer and s151 Officer. Interviews have now been held for a permanent appointment and the Interviewing Panel has offered the position to Richard Gibson and he has accepted.

It is anticipated that he will take up the position on 1st November.

RECOMMENDATION

That the appointment of Richard Gibson as Chief Finance Officer and s151 Officer be confirmed with effect from 1st November.

9. Notices of Motion

(a) Live Streaming of Meetings

To be moved by Councillor D. Whipp and seconded by Councillor D. Lord –

That this council continues to live-stream full council meetings; that principal committee meetings also be live-streamed to the council's YouTube channel; and that a report is presented to the Policy and Resources Committee on the implementation of this extended policy.

(b) Openreach

To be moved by Councillor T. Whipp and seconded by Councillor D. Lord –

Council welcomes the announcement that Openreach has agreed to roll out gigabit speed fibre to the premises (FTTP) broadband to further areas of Pendle following the Council resolution and subsequent meeting between the company and the then Chief Executive and Deputy Leader of the Council earlier this year and that residential and business properties served by the Earby and Nelson exchanges will be enabled for FTTP in the coming months.

Council notes that Openreach has yet to include properties served by the Colne exchange in the FTTP upgrade, leaving Trawden, Laneshaw Bridge, Foulridge and other rural residents around Colne on the wrong side of the digital divide.

Accordingly, Council resolves that the Chief Executive requests Openreach to include residents and businesses served by the Colne exchange in their Fibre to the Premises Programme at the earliest opportunity.

(c) Drivers

To be moved by Councillor B. Newman and seconded by Councillor T. Whipp –

Council notes the impact of a shortage of lorry drivers on Council services, especially street cleaning and refuse collection. Council resolves that a report on the issues is presented to the next Policy and Resources Committee.

(d) Flooding in Barnoldswick

To be moved by Councillor M. Adams and seconded by Councillor D. Whipp –

Council notes the significant flooding in Barnoldswick during the intense rainfall on the evening of 9th September which affected many properties throughout the town.

Council thanks the manager and staff of the Environmental Services Team for quickly responding and delivering sandbags for affected residents and businesses.

Given the magnitude of the flooding event, with water pouring into scores of homes and businesses across the town, Council believes grants for property level protection should be available for those affected.

Council resolves;

- (1) That the Secretary of State is requested to make such grants available and that the Member of Parliament, Andrew Stephenson, be asked to help secure such assistance.
- (2) That, following consideration by the West Craven Committee, the Policy and Resources Committee consider a report on the flooding with a view to identifying any action that can be taken to reduce the risk of further flooding in future.

(e) Greenhouse Gas Emissions and Renewable Energy

To be moved by Councillor T. Whipp and seconded by Councillor M. Adams -

That Pendle Council:

- (i) acknowledges the efforts that this Council has made to reduce greenhouse gas emissions and promote renewable energy;
- (ii) further recognises that very large financial setup and running costs involved in selling locally generated renewable electricity to local customers result in it being impossible for local renewable electricity generators to do so, that making these financial costs proportionate to the scale of a renewable electricity supplier's operation would create significant opportunities for local companies, community groups and councils to be providers of locally generated renewable electricity directly to local people, businesses and organisations, if they wished, and that revenues received by such local companies, community groups or councils that chose to become local renewable electricity providers could be used to help improve the local economy, local services and facilities and to reduce local greenhouse gas emissions;
- (iii) notes that the Parliamentary Environmental Audit Committee, as a result of its 2021 Technological Innovations and Climate Change inquiry, recommended that a Right to Local Supply for local energy suppliers be established to address this;
- (iv) accordingly resolves to support the Local Electricity Bill currently supported by a crossparty group of 264 MPs and which, if made law, would establish a Right to Local Supply which would promote local renewable electricity supply by making the setup and running cots of selling renewable electricity to local customers proportionate to the size of the supply company, and
- (v) further resolves to inform the local media of this decision, write to local MPs, asking them to support the Bill and write to the organisers of the campaign for the Bill expressing its support.

(f) Curry on the Street

To be moved by Councillor D. Lord and seconded by Councillor M. Adams –

Council congratulates James Foy and Curry on the Street on receiving the award in the Volunteer Category in the Radio Lancashire Make a Difference Awards.

Council recognises the importance of Curry on the Street in supporting homeless people and people with mental health problems in the Borough.

Council resolves that the Policy and Resources Committee consider a report on how this Council can assist Curry on the Street and other like-minded organisations in their work.
