# TOWNS FUND 5% CAPITAL PRE-PAYMENT AND EARLY PROJECT DEVELOPMENT COSTS

### PURPOSE OF REPORT

To inform committee of a 5% capital funding pre-payment that will be made to Pendle Council by the Department of Levelling Up, Housing and Communities (DLUHC) following project confirmation. To agree the recommendation from the Nelson Town Board that some of this funding is used to cover early project development costs needed to support business case development.

### RECOMMENDATIONS

That this committee:

- (1) Note the proposed early capital payment of 5% of Nelson's Heads of Terms offer to Pendle Council as the accountable body.
- (2) Agree the recommendation from the Nelson Town Board that part of this pre-payment is used to fund early project development costs needed to support business case development.

### **REASON FOR RECOMMENDATIONS**

To support the timely development of Town Deal project business cases.

### ISSUE

### Background

 To support with project delivery, DLUCH are releasing an early capital payment of 5% of Nelson's Heads of Terms offer (equivalent to £1.25m) to Pendle Council as the accountable body. The intention of the funding is to enable early-stage activity in project development and delivery in a way that provides value for money.

- 2. Funding can only be spent on projects listed in our Grant Offer letter and can be spent in advance of business cases being completed and summary documents signed off by DLUCH.
- 3. Payment is expected to be made to the Council once projects have finalised project confirmation (late October/early November) and it is for the Council's S151 officer to agree eligible costs working with the Town Deal Board.
- 4. Funding is expected to be spent in this financial year, and accountable bodies may use freedoms and flexibilities available to them in order to achieve spend.

#### Early project development costs

- 5. As outlined in the previous item on the agenda, in order to secure and release funding for project delivery, business cases need to be prepared for each Town Deal project in line with the Treasury Green Book five case model. Hatch have been appointed by Pendle Council to assist project leads with this work.
- 6. To inform the development of the business case, a number of projects will incur development costs relating to feasibility/design work, etc, needed to feed into the business case development process. The individual project leads are best placed to procure and manage the support/services they require and following discussion with them it is estimated the cost of this work will be in the region of £350k. The funding required to undertake this work will be accommodated within each project's overall budget/Towns Fund allocation.
- 7. Given that this expenditure will be incurred prior to the business cases being assured and ultimately signed off by Government, there is the risk that this expenditure is an abortive cost should the project not prove viable to proceed. In these circumstances, DLUHC will not seek to claw back the 5% early draw down, however the pre-payment is netted off the overall offer and DLUCH cannot guarantee that unviable projects would be replaced at an equivalent value.
- 8. To enable this development work to proceed, the Town Deal Board are recommending to the Council's Policy and Resources Committee that part of the Towns Fund pre-payment is used to fund these early project development costs. Subject to Committee approval, and in line with the views of the Council's Interim S151 officer, further details will be sought from project leads regarding the outputs from this expenditure and how it supports project development and delivery; and relevant agreements will be put in place.
- 9. Accountable bodies will be expected to report on this funding, and these requirements will be set out shortly by DLUHC.

#### **Revenue Funding**

10. Revenue funding will be treated separately to the early capital payment. Project specific revenue funding will be paid out against individual projects once summary documents are approved by DLUHC. At least one project requires revenue funding to commence delivery in 2021/22 (the YES Hub) and for this, the business cases will need to be completed, appraised and summary documents submitted to DLUHC by 14<sup>th</sup> January 2022.

### IMPLICATIONS

**Policy:** None directly arising from this report.

**Financial:** Any Towns Funding spent on early project development activity will be from within the project's notional Towns Fund allocation. There is the risk that this expenditure is an abortive cost should the project ultimately not prove viable to proceed. DLUCH would not seek clawback of this funding and they cannot guarantee projects would be replaced at an equivalent value.

Subject to further details being provided by project leads regarding how this early expenditure supports project development and delivery, the Council's Interim S151 officer is in agreement with the Board that these would be eligible project costs.

**Legal:** Agreements will be put in place between Pendle Council as the accountable body and the lead project organisations regarding the use and drawdown of this funding.
