# TREE PLANTING ON RINGSTONE CRESCENT, NELSON

#### **PURPOSE OF REPORT**

- 1. To remind Members of the Council's decision in July 2019 to declare a Climate Emergency and set out an emergency action plan which included supporting the Lancashire Woodland Connect to increase tree and woodland cover.
- 2. To inform Members of residents' objections to the planting of an orchard on Ringstone Crescent and in the light of these objections to recommend that the scheme does not proceed.

#### **RECOMMENDATION**

That the planting of an orchard on Ringstone Crescent, Nelson is not approved.

#### REASON FOR RECOMMENDATION

In response to objections received from local residents.

## **ISSUE**

- 1. At the Policy and Resources meeting of 17<sup>th</sup> September 2020 it was resolved that a number of Council owned sites be allocated for tree planting to help with our efforts to combat and lessen the impacts of climate change. Included in the list of sites was Ringstone Crescent.
- 2. Due to the site being urban and close to residential properties, a scheme was produced to create four orchards on the site (Appendix 1). This schemes design meant that the tree provision remained relatively small, open space would be retained, it would provide a source of free fruit for local people and provide volunteers with opportunities to learn new skills.
- 3. Local Councillors became aware of residents objecting to the proposal. In response to these objections the issue was raised at the June meeting of Nelson, Brierfield and Reedley Area Committee where it was resolved that;

- '(1) That the decision to consult with Ward Councillors and local residents on the proposed tree planting scheme for Ringstone Crescent, Nelson be implemented and the consultation be carried out as soon as possible.
- (2) That the results of the consultation be brought back to this Committee.'
- 4. The consultation was held at Ringstone Crescent on Monday 9<sup>th</sup> August. Residents attending the event submitted a petition, letters and comments which can be summarised as follows:
- 5. The majority of the residents around the Crescent area are against any form of tree planting on the site.
- 6. The residents additionally produced a copy of the Land Registry documents for the site claiming that this showed there is a covenant on the land preventing the Council from growing anything on it. Legal advice sought after the event advises that this does not apply to the Ringstone Crescent site but to a section of Marsden Park.
- 7. The land allocated by this Committee equates to around 30 hectares of new tree planting sites. Ringstone Crescent is 2.35 hectares, around 8% of the land mass of all the proposed planting sites.
- 8. In conclusion there are sound reasons for planting on this site but at the same time there is strong local opposition to it. The very reluctant officer view is that the Council should not proceed with it in the face of such opposition.
