5. Parking Concerns / Requests for Restrictions

- 5.1. Carr Road, Nelson – LCC have received reports of a danger to pedestrians when crossing Carr Road opposite the garages (nos 87 to 109) with a request for a crossing. The request does not specify where the crossing should be located. It's proposed that double yellow line are marked on the southside of Carr Road at junction with Norfolk Street and make the crossing points further down Carr Road to a mobility crossing with tactile paving and another crossing point just above West Street. **Agreed by TLM.**

- 5.2. Dockray Street, Colne – The business on Dockray Street has been having problems with deliveries due to parked cars blocking their entrance. LCC have spoken to the owners on site. The lines on Water Street are to be re-marked. The waiting restrictions on the entrance on Dockray St are also to be added to deter people blocking the entrance. **Agreed by TLM.**

- 5.3. Sandy Lane, Barrowford – LCC have received reports of parking problems occurring on the narrow footway blocking the entrance to properties on the south side where the footway is narrow. It is proposed to add a double yellow outside 23 Sandy Lane where the carriageway is at its narrowest. **Agreed by TLM.**

- 5.4. Albion Road, Earby – LCC have received a report of vehicles parking on the double yellow lines at Albion Road junction with Colne Road & Skipton Road causing footway obstruction for people with prams and motorists having difficulty turning the corner (especially buses). Lancashire Parking Services (LPS) are currently unable to enforce as the TRO is for a single yellow. The TLM agreed to liaise with LCC's Public and Integrated Transport Team regarding a potential double yellow at the junction and then a single round the corner. **Agreed by TLM.**

- 5.5. Sheridan Road, Laneshawbridge – LCC have received a request from members of the public to convert the verge on the south side of Sheridan Road to parking bays as was done on the north side some years ago. The Fire Service have also had issues with access on Sheridan Road due to parking cars. However there is no funding available for this. As an alternative LCC are suggesting restrictions at strategic points (where driveways are located). The Watch Manager from Fire and Rescue, Colne Fire Station has given support to this to allow their appliances to access the Road if needed. Agreed that Fire and Rescue should be consulted on the plans. **Agreed by TLM.**

- 5.6. Sheridan Road, Laneshawbridge – LCC have received complaints regarding a resident using barrels to reserve a parking space outside their property. A letter was sent to the resident to desist from this activity but this has not resolved the issue. It was agreed that GM would speak to the resident and if the issue continued LCC would speak to their Legal team regarding notice procedures and take the appropriate action accordingly. **Agreed by TLM.**

6. Speed / Traffic Concerns

- 6.1. Skipton Road, Barnoldswick – LCC have received concerns around crossing on Skipton Road Barnoldswick near to the canal bridge. There are no current mobility crossings in the immediate vicinity to assist crossing. One proposed solution would be to provide a tactile crossing at the top of the bridge where there is the most visibility in both directions. It was agreed to proceed to informal consultation. **Agreed by TLM.**
- 6.2. Back 2 to 20 Park Street, Barnoldswick – LCC have received a complaint from a local resident reporting damage to his garage from vehicles turning the corner. The residents has suggested that the installation of bollards at the corner would prevent any damage to his garage. It was agreed by the group that the back street was wide enough and that TLM could not see any justification for adding bollards – **TLM agreed no further action.**
- 6.3. Vivary Way, Colne – LCC have received a report from a member of the public that vehicles are using the right turn lane on Vivary Way to go straight on through the traffic lights on the junction with Barrowford Road and Crown Way. There is often a queue of traffic at this junction which motorist have tried to avoid by cutting into the left lane just before the lights, however we have since installed bollards between the two lanes to prevent this type of manoeuvre. LCC advised that the Signals team are looking at amending the timing on the signals. TLM suggested that a static camera at this location would be supported by the group. GM to refer to speed team. **Agreed by TLM**

7. Developments

- 7.1. Toucan Crossing on Barrowford Rd – JS advised the group that the crossing was now in place. Improvements to the footway and carriageway are to take place shortly and that the scheme is now close to completion. **Noted by TLM**
- 7.2. JS advised the group of a planning application at the former warehouse on Regent Street Colne Boundary Mill and asked for any knowledge of previous applications? The group noted the location and were not aware of any historical applications. **Noted by TLM.**

8. Pendle Borough Council Items

- 8.1. Trawden Road/Cotton tree Lane – Reports of a vehicle being repeatedly parked at the junction of Trawden Road / CottonTree Lane and Winewall Road. Enforcement of this vehicle would also require enforcement on the other vehicles to the right of the image as these are also parked within the system of double white lines where there is limited provision for residents to park. **MH agreed to speak to Councillor**
- 8.2. Wilton Street, Barrowford – Following on from a request from Barrowford AC for additional parking enforcement on Wilton Street residents only the committee in Sept have now come back with additional issues including a request for a one way system on Wilton Street to help ease the problems. Whilst the TLM agreed that they could not support an application for one way as the Wilton Street is a cul de sac, it was agreed that Lancashire Parking Services would look at weekend enforcement of the residents parking area. **Agreed by TLM**

9. Police Items – Nothing to report

10. LCC HQ Items

- 10.1. CN advised of some required amendments to TRO's for Stanworth Road to Broad Street Nelson and the Albert Street Order Barnoldswick. **Noted by TLM**
- 10.2. MI advised that there is already a non-formalised existing residents only parking scheme to the rear of Forest View Barrowford; LCC have checked the land ownership and will be looking to formalise the residents only parking in this area and will be carrying out consultation shortly. **Noted by TLM**

11. Any Other Business

- 11.1. Clitheroe Road, Brierfield Pendle Council Officers have received a report from a Cllr regarding a parking bay on Clitheroe Road near its junction with Quakers View (no restrictions in place or TRO shown on Mapzone). Concern has been raised regarding sightlines as vehicles emerge from Quakers View into Clitheroe Road. When vehicles are parked right up to the junction it restricts the visibility of cars heading westbound on Clitheroe Road. The Cllr has requested that we remove the space for a vehicle and extend the existing hatching to help improve visibility. Following a discussion it was agreed that junction protection would be required, which would necessitate a consultation; therefore LCC will check on site and report back to a future meeting. **Agreed by TLM**
- 11.2. The Cllr also asked about Chatburn Park Drive/Quakers View/Roundwood Ave and Wood Clough Platts being added to the 20mph speed limit for residential streets. The TLM agreed that the

Quaker View development will have been designed to lend itself to a 20mph scheme and for similar reasons Roundwood Avenue would not meet the criteria as it's a cul de sac. Whilst Chatburn Park Drive is an older housing development it will not have been included in the original 20 mph scheme as it did not meet the criteria however it was agreed that a to double check a speed survey will be carried out on Chatburn Park Drive. **Agreed by TLM**
