A COUNCIL TAX 2022/23 - CALCULATIONS

It is recommended that the Band D Council Tax for the Borough of Pendle services be set at £281.50 for the financial year 2022/23

B COUNCIL TAX DECLARATION

The Council is recommended to resolve as follows:-

1 It be noted that, at the meeting of Policy and Resources Committee on the 16th December 2021, it was agreed that the Council Tax Base 2022/23:-

a for the whole Council area would be 23,940.60; (Item T in the formula in Section 31B of the Local Government Finance Act 1992, as amended (the "Act")); and

b for dwellings in those parts of its area to which a Parish precept relates would be follows:
