#### 7. <u>Declarations of Interest</u>

Members are reminded of the legal requirements concerning the declaration of interests.

A Member must declare a disclosable pecuniary interest which he/she has in any item on the agenda. A Member with a disclosable pecuniary interest in any item may not participate in any discussion of the matter at the meeting and must not participate in any vote taken on the matter at the meeting.

In addition the Council's Standing Orders require a Member with a disclosable pecuniary interest to leave the room where the meeting is held while any discussion or voting takes place.

#### 8. Appointment of Leader and Deputy Leader

#### 9. Local Government and Housing Act, 1989 - Political Balance Rules

Whenever the allocation of seats on Committees is reviewed the Council is required to apply the statutory political balance rules.

The rules apply to the Policy and Resources Committee, Licensing Committee, the Accounts and Audit Committee, Employment Appeals Committee and Standards Hearing Committee. They do not apply to the Area Committees.

#### 10. Appointment to Committees

- (a) To consider the appointment of Members to Committees for the Municipal Year 2022/23. The list is a reflection of the Committees the Council currently appoints, together with numbers currently on them:
- (i) Policy and Resources Committee a politically balanced Committee of 9 Members
- (ii) Accounts and Audit Committee a politically balanced Committee of 5 Members
- (iii) Licensing Committee a politically balanced Committee of 9 Members
- (iv) Employment Appeals Committee a politically balanced Committee of 3 Members
- (v) Standards Hearing Committee a politically balanced Committee of 5 Members
- (vi) Taxi Licensing Sub-Committee a politically balanced Committee of 9 Members
- (vii) Area Committees not politically balanced
- (b) That with effect from 1<sup>st</sup> September Area Committees no longer be responsible for planning matters and that a Planning Committee be established to take on this function and that the Corporate Director be requested to report to the next meeting on this and consequential changes to the terms of reference and operations of Area Committees.
- (c) That the Corporate Director be requested to submit a report to the next meeting on possible improvements to the call in procedure for decisions of the Policy and Resources Committee.
- (d) That the Corporate Director be requested to submit a report to the next meeting on the rules of procedure at Council and Committee meetings in relation to members speaking and points of order and personal explanation.

#### 11. Appointment of Chairmen of Committees

- (a) To appoint Chairmen of the following Committees:
- (i) Policy and Resources Committee
- (ii) Accounts and Audit Committee
- (iii) Licensing Committee
- (iv) Taxi Licensing Committee
- (v) Employment Appeals Committee

The Rules of Procedure at Committee Meetings allows Area Committees to appoint their Chairmen. Difficulty has arisen with this at the West Craven Committee last year and this year as the Conservative and Liberal Groups both have three Members and this has led to deadlock.

This is an unsatisfactory situation and it is **RECOMMENDED** that Rule 5.2 of the Rules of Procedure at Committee Meetings be amended by the addition of the following:

"Where, for whatever reason, an Area Committee is unable to appoint a Chairman the Council shall make the appointment."

If this recommendation is approved the Council can then proceed to make an appointment.

#### 18. NOTICES OF MOTION

#### (a) VAT Reduction and Windfall Tax

To be moved by Councillor David Whipp and seconded by Councillor Tom Whipp -

Council notes the drastic impact of the cost-of-living crisis on Pendle residents and resolves to request the Chancellor of the Exchequer to reduce VAT to 17.5% as an emergency measure and to introduce a windfall tax on the profits of energy companies.

#### (b) Local A&E and Ambulance Response Times

To be moved by Councillor Dorothy Lord and seconded by Councillor David Whipp –

Council notes the huge pressure on hospital Accident and Emergency departments and the knock-on effect on ambulance services and their response times.

Council resolves that the Chief Executive writes to the Secretary of State for Health and Social Care to request urgent action to address waiting times at local A&E's together with ambulance response times.

#### (c) Local Elections

To be moved by Councillor Tom Whipp and seconded by Councillor David Whipp –

Council notes the dismal turn-out at the recent local elections in many wards, as well as the many seats that were filled with less than 50% of the vote going to the winning candidate.

#### Council therefore resolves:

- (1) To write to HM Government and the MP for Pendle, expressing this Council's concern for voter apathy and disenfranchisement and the effects this has on local and national democracy.
- (2) To ask HM Government to introduce measures to increase voter turnout, such as a national holiday on polling day, or a small council tax rebate for each member of a household going to the polls.
- (3) To demand that HM Government end First Past the Post voting in England and hold a referendum on which type of voting system should be implemented instead.
- (4) To announce support for the Make Votes Matter campaign.
- (5) To express dismay at the Government's Act implementing voter suppression through use of photo ID for voting.
