## 5. Parking Concerns / Requests for Restrictions

- 5.1. A56 Skipton New Road junction with Causeway, Foulridge – parking and visibility issues – a request has been received for pedestrian guardrails on the south side of the junction with Causeway to deter vehicles from parking on the existing double yellow lines. The TLM discussed the possibility that guard rails may reduce visibility for drivers turning onto A56. The proposal is for loading restrictions to allow immediate enforcement on the junctions. TLM suggested extending the limited waiting bay outside the shops to the south and creating a loading bay area outside the shops which will deter the obstructions to the double yellows. **TLM agreed to progress to informal consultation**
- 5.2. Blacko Bar Road, Roughlee – a request has been received for parking restrictions at the bus stop opposite Roughlee Primary School on Blacko Bar Road. LCC's Bus Services team are aware of issues around school peak times and would support a bus box. It is not possible to amend the bus timetable as school children rely on this service in this rural location. The TLM discussed parking in the area and agreed that additional parking restrictions would push the problem to another area. **TLM agreed to look at a Bus Stop Clearway.**
- 5.3. Colne Road towards Westgate, Barnoldswick – LCC has received reports of parked vehicles on Colne Road and Westgate which are preventing the free flow of traffic, including gritters. The customer has requested double yellow lines on one side to prevent double parking. The winter maintenance managers have reported no issues with gritters on this route and there are no recorded injury collisions. The TLM agreed that the addition of a short length of double yellow lines on the inside of the bend opposite No. 1 – 9 Town Head would improve the site lines. **TLM agreed to progress to informal consultation**
- 5.4. Queen Street, Colne – a member of the public has reported concerns over visibility of oncoming traffic when turning onto Queen Street from Brown Street West. There is one collision recorded in the vicinity. The TLM discussed the merits of the request and on balance agreed that there was no merit in introducing additional restrictions. **TLM agreed no further action.**
- 5.5. Wenning Street, Nelson – A resident of Wenning Street has reported vehicles relating to various garages being parked on the bend and further up the street, preventing residents from parking on the street and obstructing access for emergency services. The TLM agreed that a double yellow line on one side and a single yellow opposite (to accommodate residential parking) would alleviate the problems. **TLM agreed to progress to informal consultation**
- 5.6. Wheatley Lane Road, Fence – reports of vehicles at school peak time causing obstruction – The TLM agreed that any additional restrictions in the area would only move the parking problems. **TLM agreed no further action.**

5.7. Barley Parking Restrictions Following the TTRO for parking restrictions in Barley, LCC are looking to make the order permanent. Furthermore the following restrictions have been requested by the Parish Council: 1. DYLS on the bend near Barley Methodist Church, an extension of the DYLS furthest north on Barley Lane and the removal of the DYLS second furthest north on Barley Lane and additional DYLS on southbound side (the north east side) near the village hall. **TLM agreed to progress as above**

## **7. Developments -**

7.1. McDonalds Nelson development. SW advised the group that he had been on site. The works include replacement footways on Sagar Street and Broadway in tegula block paving and improvements to the pedestrian refuges and the pelican crossing on Broadway will be upgraded to a puffin. The development is due to start in December 2022.

7.2. Pasture Lane development for 250 houses in Barrowford - KH advised the group that mitigation measures including a mini roundabout at the junction with Lupton Drive/Church Street, traffic calming on Church Street and footway widening are being proposed by the developer. LCC are still maintaining their objection to the development

7.3. Lenches Road – LCC will be submitting an objection to this development based upon lack of pedestrian facilities.

7.4. Primet Academy – JS advised the group that 2 twin temporary classrooms with internal ramp and fencing were being erected to the rear of the school (whilst the permanent classrooms are being constructed). Access for the construction phase would not be from Briercliffe Avenue and this would be controlled as part of a Construction Traffic Management Plan.

7.5. Queen Street Nelson – With regard to the obstruction on the highway following discussions with LCC's Legal team it was agreed that no further action would be taken at this time

## **8. Pendle Borough Council Items**

Wilton Street Barrowford – SW advised the group that following a report to Barrowford AC Officers are now looking at creating some additional parking on the site of the hub which will alleviate the on street parking. The addition of

parked traffic on the access to the hub will also help to keep speeds down and improve road safety.
