REASON FOR DECISION

On the balance of probability, the wording of the condition relating to "a maximum of 14 boarding dogs" relates to overnight accommodation and therefore providing a day care facility for dogs during the day where they return home at night is not a lawful use of the land in accordance with Planning Permission 13/07/0408P.

39. TRAFFIC ISSUES ON WILTON STREET, BARROWFORD

At a meeting of the Barrowford and Western Parishes Committee it was resolved "that Nelson, Brierfield and Reedley Committee and Nelson Town Council be requested to consider making, between them, a contribution of £6,000 towards the cost of the proposed schemes referred to in (2) and (3) above."

For information the proposed schemes were:

- (a) Erection of direction signage (£450) and formalised parking bays (£500) to encourage the use of the car park off Cravendale Avenue, Nelson.
- (b) Provide a car park next to the Steven Burke Hub using funding secured from the Lancashire Environmental Fund and to create a new parking area at location B (on the plan submitted) at an additional estimated cost of £11,000.

RESOLVED

That this request be referred back to the Barrowford and Western Parishes Committee to reconsider and if there was not sufficient funding in their Capital Programme then it be suggested that they make a request to the Policy and Resources Committee for a supplementary estimate.

REASON

The Committee's Capital Programme for 2022/23 had been fully committed.

40. PUBLIC SPACES PROTECTION ORDERS – DOG CONTROL

The Chief Executive submitted a report on proposals and options for the renewal of the Dog Control Public Spaces Protection Order (PSPO).

A public consultation exercise had been carried out during May and June and the comments received were attached to the report at Appendix 1.

RESOLVED

That the renewal of the Dog Control Public Spaces Protection Order be approved and sites in Nelson, Brieffield and Reedley be included in it, as set out in the Order.

REASON

To enable the Council and its partners to respond to concerns regarding behaviour that was detrimental to the quality of life in public spaces in Pendle, including enforcement action.
