- (4) That the frequency of Area Committee meetings be retained on a monthly basis.
- (5) That Area Committee budgets be maintained at £170,000 and continue to be apportioned according to the electorate of each Area Committee.

#### 29. CALL IN PROCEDURE

The Corporate Director submitted a report which provided information on the operation of the call in procedure with suggested improvements.

Since the implementation of the Committee System in May 2018 there had been 14 decisions which had been called in. Of the 14 call in notices four did not proceed due to a change in circumstance or lack of support from Group Leaders. Three led to a change to the original decision and seven led to no change.

At the last Annual Council meeting it had been resolved that the Council move back to executive arrangements in May, 2023. As a result, and with the need under the Localism Act 2011 for the

inclusion of at least one Overview and Scrutiny committee the power to review or scrutinise decisions made or action taken by the Executive was required.

It was therefore recommended that the remainder of the municipal year the call in procedure stays substantively the same.

#### **MOTION**

It was moved by Councillor N. Ahmed and seconded by Councillor D. Cockburn-Price –

That the Group Leaders and Corporate Director scrutinise the reasons given in call in notices to ensure that a call in is appropriate and the procedure is consistent and transparent.

Upon being put to the vote the Motion was LOST.

#### 30. RULES OF PROCEDURE

The Corporate Director submitted a report on proposed amendments to the Rules of Procedure in relation to members speaking and points of order and personal explanation at Council and Committee meetings.

#### **MOTION**

It was moved by Councillor N. Ahmed and seconded by Councillor D. Albin -

(a) The addition of the following Rule to apply at all meetings:

Councillors' General Conduct at meetings

All Councillors shall:

- Respect the Chair at all times;
- Adhere to the Councillor Code of Conduct;
- Recognise and acknowledge that they are personally responsible for their own conduct and have a responsibility to secure and promote good conduct on the part of all councillors and of their political group;
- Have regard to the need to demonstrate a standard of conduct and behaviour which supports
  healthy and constructive debate and which meets the expectations that local people will hold of
  their elected representatives;
- Regain from personal attacks on any other councillor, notwithstanding the acceptance of robust political debate.
- (b) That permission of the Chairman be required to raise a point of personal explanation and that the ruling was not open to further discussion. Rule 14.11 would be amended to read:

With the permission of the Mayor a Member make a point a point of personal explanation. A personal explanation may only relate to some material part of an earlier speech which may appear

to have been misunderstood in the present debate. The ruling of the Mayor on the admissibility of a personal explanation shall be final and not open to further discussion.

(c) When raising a point of order a Member must, at the outset, state what Rule of Procedure or law they consider had been broken, in what way and that the ruling not be open to further discussion. Rule 14.12 wold be amended to read:

A Member may raise a point of order in relation to an alleged breach of a Rule of Procedure or law and shall be entitled to be heard immediately. The Member must, at the outset, specify the Rule of Procedure or law and the way in which they consider it has been broken. The ruling of the Mayor on a point of order shall be final and not open to further discussion.

#### **Lancashire Police and Crime Panel**

The proportionality for representatives across Lancashire has been worked out and a request has been received for a representative to be nominated from the Liberal Democrat Group to balance the Panel.

That Councillor D. Whipp be appointed as the additional representative on the Lancashire Police and Crime Panel.

#### 32. NOTICES OF MOTION

#### (a) Street Sweeping

It was moved by Councillor D. Whipp and seconded by Councillor D. Lord -

Council notes that street sweeping has been adversely affected by the reduction in mechanical sweepers being used in Pendle since April, with a 'fire-fighting' approach being used in areas not now receiving regular sweeping.

Council also notes that the proposed saving of £24,000 from the cut in sweeping had not been achieved due to a £20,000 penalty in the contract for the mechanical sweeper.

Council resolves that the budget for mechanical sweeping was reinstated and that previous sweeping routes and frequencies were restored.

Upon being put to the vote the Motion was **CARRIED** and it was –

# (b) Sustainable Development

It was moved by Councillor T. Whipp and seconded by Councillor D. Whipp -

Council reaffirms its commitment to combat the climate crisis, notes that a major contributor to carbon emission s is domestic space heating and that energy cost increases are becoming increasingly unaffordable for households.

Council believes that the borough council should set an example in promoting sustainable development through positive action.

Accordingly, Council resolves that £371,000 of the Brownfield Sites fund be allocated for the provision of air-source heat pumps at the brownfield development at Spring Mill, Earby by the Council's joint venture PEARL Together.
