9. <u>Environmental Blight</u>

10. <u>Dotcliffe Road, Kelbrook- grass verge and parking issues</u>

At the last meeting a response from the Head of Grounds Maintenance at Together Housing was reported on grass cutting at this location and the condition of the trees.

The Council's Environment Officer has also visited the site to have a look at the trees on the grassed area outside 10 Dotcliffe Road. At the time he carried out the inspection, he couldn't see any issues that concerned him and said that both structurally and physiologically the trees appeared to be in reasonable health. He said that one of the trees was an Ash which had minor signs of 'Ash Dieback', and for that reason, he would advise that the tree owners carry out an inspection on an annual basis to monitor this disease. Together Housing have been notified. The other tree was a Sycamore and appeared to be fine at the time it was inspected.

The Planning, Economic Development and Regulatory Services Manager will provide an update at the meeting on whether the planning approval conditions for the developments on Dotcliffe Road had been implemented as required.
