7. Brief details of project:...... The Cricket Club has been working with the ECB for several years to secure a grant for this project to install all-weather practice nets. This training facility will allow the players to continue practicing out of season, without having to resort to the expense of hiring sports halls which are not close to the club.

The lack of such a facility has put the Club at a competitive disadvantage compared to other clubs in East Lancashire.

The total external cost of the project is $\pounds 29,495+VAT$ (see attached), of which $\pounds 20k$ will be secured from the ECB and $\pounds 6k$ has been raised so far from the Club's own resources. It is envisaged that the Club will raise the balance of the funds ($\sim \pounds 1.5k$), after the Colne Area grant is hopefully received, from social events e.g. bonfire night & Christmas.
