If the item is a planning application then you must make your request in writing or by telephone by 12 noon on the day of the meeting.



PLANNING MATTERS

The Head of Legal Services and Monitoring Officer advises:

On 19th May the Council resolved:

"That with effect from 1st September Area Committees no longer be responsible for planning matters and that a Planning Committee be established to take on this function and that the Corporate Director be requested to report to the next meeting on this and consequential changes to the terms of reference and operations of Area Committees."

Area Committees therefore no longer have the power to decide the outcome of planning applications and enforcement issues.

There is, as yet, no agreed scheme of delegation and terms of reference for the Planning Committee which will assume the powers to determine planning applications previously

allocated to Area Committees. With no scheme of delegation in place all applications will need to be determined by a Committee.

Planning applications will therefore be reported to Area Committees for consideration. With no other Committee able to deal with applications decisions on all matters will need to be taken by Council until the remit of the Planning Committee is constitutionally defined.

Committee is therefore asked to consider the applications and forward their recommendations to Council.

7. Area Committee Budget 2022/23

MISCELLANEOUS MATTERS

8. Wheel Park, Vivary Way, Colne

The Environmental Services Manager reports that, following a request from this Committee, Colne Town Council has been consulted on the proposal to create a wheel park or similar facility on available land between Pendle Leisure Centre and Bowker BMW.

The matter was discussed at the Town Council's Finance, Employment and Services Committee and we have been advised that the Town Council is in support of the project. The Town Council is not in a position to contribute to the initial capital costs but, with more detailed proposals, it would be open to discussion in relation to an annual contribution of up to £10,000 for the ongoing maintenance of the park.

The Environmental Services Manager reports that in order for the project to progress beyond its current point without the initial financial support of Colne Town Council grant funding will need to be sought. Funding opportunities will be investigated once resources within Environmental Services are available to take on the work.

9. <u>Conservation Areas</u>

At recent meetings of this Committee Members have discussed a proposal for Growth Lancashire to scope the creation of new Conservation Areas in Colne and District and have indicated that they are keen to progress this.

The Planning, Economic Development and Regulatory Services Manager advises that the work has been commissioned at a cost of £644.91.

The Committee is asked to agree this funding from the Committee's budget.

10. Provision of litter/dog waste bins

Enc. Further to a request of this Committee, the Environmental Services Manager submits the attached list of litter bins within Colne Town Centre.

Members are advised that due to wear, damage or a reduced need for the facility, 13 bins have been replaced / removed by Environmental Services in Quarter 2, for the period July 2022 to September 2022.
