90. DISPOSAL OF LAND OFF HELMN WAY / MARSDEN HALL ROAD SOUTH, NELSON

The Housing, Health and Engineering Services Manager submitted a report seeking approval from Members to make a recommendation to the Policy and Resources Committee to declare the land off Helmn Way / Marsden Hall Road South, Nelson surplus to requirements for disposal by way of private treaty subject to terms and conditions.

It was reported that the land was of no operational or beneficial use to the Council and was currently a maintenance liability. It was further reported that it would not be of interest to any party other than the owners of the adjacent land and could not physically be used for anything other than as a landscaped strip.

RECOMMENDATION

That the Policy and Resources Committee be recommended to:

- (1) Declare the land off Helmn Way / Marsden Hall Road South, Nelson surplus to requirements.
- (2) Approve a sale to the owners of the adjacent land to provide an access from the highway subject to the following terms and conditions:
 - i. Area: 50.5 square meters approximately.
 - ii. Consideration: £40,000 (plus VAT if applicable).
 - iii. Use: vehicular and pedestrian access.
 - iv. Boundary treatment: the purchaser to construct a wall or fence to the Council's satisfaction to enclose the land at its own cost.
 - v. Costs: the purchaser to bear the Council's legal costs and Open Space advertising costs.

REASON

To achieve a capital receipt and remove any future liability for maintenance.

(a) Parking Spaces – Pendle Samaritans

This item was deferred from the last meeting due to the absence of His Worship the Mayor Councillor Y. Iqbal.

It was reported that the Volunteers running Pendle Samaritans were often receiving Penalty Charge Notices for overstaying, through no fault of their own, in the parking bays on Market Square, Nelson outside the Branch's office. It was then suggested that the allocation of dedicated parking spaces could be considered. Members were advised that it would be difficult to do something like that for one Town Centre organisation and not for others and applying for Business Parking Permits was suggested as an alternative. It was also suggested that Nelson Library could be approached about its car park being used outside of its business hours by the Volunteers.

RESOLVED

That the Housing, Health and Engineering Services Manager be requested to submit a report to the next meeting which considers parking options for the Volunteers of Pendle Samaritans including, but not limited to, providing dedicated parking spaces, applying for Business Parking Permits and using Nelson Library's car park outside of its business hours.
