71. COLNE NEIGHBOURHOOD PLAN

The Planning, Economic Development and Regulatory Services Manager submitted a report on the final draft of the Colne Neighbourhood Development Plan. The Plan proposals, as submitted, had been made available for public consultation which was due to close on 17th October.

The Committee were asked to consider the officer comments for submission to the Examiner. The comments were made to modify the Plan to ensure that it met with the basic conditions.

RESOLVED

- (4) That it be noted that the Officers' comments would also feed into a formal facilitation exercise to be held with Colne Town Council and Locality which would seek to agree a statement of common ground to assist the independent examiner in assessing whether the Colne Neighbourhood Plan met the basic conditions and legal requirements.
