FINANCIAL MATTERS

8. Area Committee Budget 2022/23

Enc. The Housing, Health and Engineering Services Manager reports that the current balance for the Committee's area committee budget for 2022/23 is £28,058.

In September 2020, the three Boulsworth ward councillors (Cllrs Sarah Cockburn-Price, Margaret Foxley and Paul Foxley) donated £205 each from their Councillors' Capital Projects fund for tools and trees for Ball Grove Park and Nature Reserve.

The Chairman of Ball Grove Park and Nature Reserve has recently confirmed that the group delayed purchasing the tools until they were provided with suitable storage facilities adjacent to Ball Grove Café but as they still have no storage they have cancelled the purchase plans. In addition, they were subsequently granted £450 from the Council's Localities and Policy Team for the trees using the Small Climate Action Grant funding.

Members are therefore recommended to de-allocate the funds and re-allocate them to the three current Boulsworth & Foulridge ward councillors (Cllrs Sarah Cockburn-Price, David Cockburn-Price and Kevin Salter).

Members are also recommended to de-allocate an underspend of \pounds 56.38 for last year's Colne Light Festival and return the funds to the general pot. Out of a total of \pounds 1,000 allocated, the total spend came to \pounds 943.62.
