## **5. Parking Concerns / Requests for Restrictions**

### **5.1. Colne Road, Sough – Request for parking restrictions to prevent HGV parking**

MW outlined details regarding large work vehicle parked on carriageway. MH suggested speaking to GM outside meeting for advice. MH suggested the possibility of a h-bar.

### **5.2. Skipton New Road, Foulridge – Parking restrictions to improve visibility at junction with Causeway**

MW outlined proposal for No Loading restrictions and detailed the results of an informal consultation. The group raised no objections to the proposal.

### **5.3. Carr Road, Nelson – Canal Bridge NWAAT**

MW outlined proposal and details of informal consultation. SW supported not extending the restrictions in front of No. 70. MW awaiting response from Cllr.

## **6. Speed / Traffic Concerns**

### **6.1. Manchester Road, Barnoldswick – speeding concerns**

MW outline enquiry relating to vehicular speeds along this section of carriageway. JS provided the outcome of a traffic count that was conducted in the area. To be queried with LRSP to find out what proposals were planned for this section of road.

### **6.2. Skipton Road, Earby – request for warning signs**

MW outlined request from Earby Parish Council to introduce additional warning signs to indicate elderly/disabled people. A group discussion followed including the existing signage provision for other hazards. Decision made to supply additional signage to be consistent with the existing signage on the northbound carriageway.

## **7. Developments**

1. New signalised junction Whitewalls Drive, Colne for Eurogarages site starting soon.
2. Oaklands housing site Wheatley Lane Road (80 houses) currently being considered by the Planning Inspectorate via written representatives.
3. Larger Pasture Lane site, alternative access options are being explored under a pre-app, not in the public domain yet.

4. Barnsay Shed, Long Ing Lane, Barnoldswick housing site (120) pending a decision. Essex Street/Rainhall Road traffic signals to be assessed. To be queried with Kelly Holt.
5. Former Riverside Mill housing site (140), Charles Street, Nelson pending a decision.
6. Former ELE Technologies housing site (50), Cotton Tree Lane, Trawden pending a decision.

Traffic orders team – TP informed group that Peter Bell is applying for moving traffic enforcement powers. Also TRO Team looking to review the existing moving orders in relation to the enforcement powers being applied for.

Moss Houses Road, Colne, 'Noyna Ford' – LCC currently investigating a Prohibition of Driving Except Permit Holders. Possible introduction of Experimental TRO.
