# 80. MEDIUM TERM FINANCIAL FORECAST (2023/24 to 2025/26) WITH REVENUE AND CAPITAL BUDGETS FOR 2023/24

The Director of Resources submitted a report which considered the Medium Term Financial Forecast for 2023/24 to 2025/26. A number of scenarios were included in the report which ranged from the 'status quo' position to a 'do minimum' position and finally actions required to achieve a balanced budget over the medium term and beyond.

The report also considered the Revenue and Capital budget position for 2023/24 and highlighted the existing revenue gap between expenditure and income and the need to draw down from general reserves. The report focused on the Council's financial strategy towards the agreed transformation programme whilst also covering the themes of growing, charging, saving and stopping.
