#### 5. Parking Concerns / Requests for Restrictions

5.1. **Boot Street, Earby** – a request has been made to review the restrictions on the south-east side outside Victoria Mill. The suggestion is for new loading bay and limited waiting for customers. The restriction is currently No Waiting at 8am to 6pm.

SW advised the group that businesses within the Mill are struggling for loading and unloading and also for visitors to the Business.

TLM Agreed that LCC and Pendle Officers will look on site to check road widths on Boot Street and bring back to the next meeting.

5.2. **Hollin Hall, Trawden –** A request has been received from Trawden Forest Parish Council for new double yellow lines along Lane House Lane, Slack Booth and Hollin Hall. The Parish Council have asked for the following restrictions – Double yellow lines on the south west side outside 42 Lane House to Slack Booth Barn and North East side outside 6 Hollin Hall to 14 Floates Mill.

The TLM agreed that so extensive restrictions would disrupt residential parking. It was felt that restrictions on a couple of pinch points would be more suitable. The new development in the area will also be looking at restrictions outside Floates Mill.

TLM Agreed LCC and Pendle Officers and Trawden PC to meet on site to discuss further and for the issue to be brought back to a future meeting

5.3. **Colne Road, Kelbrook** – LCC have received an enquiry from the head teacher of Kelbrook Primary School. Issues have been reported with vehicles parking in the layby area, footways and verges, as well as drivers making manoeuvres such as u-turns in front of the traffic island before the roundabout.

LCC have carried out a site visit at school picking up time. TLM agreed that the layby took vehicles off the carriageway and additional restrictions may raise further issues on Waterloo Road which is the main picking up/dropping off location.

TLM Agreed - No further action to be taken

5.4. Leonard Street, Barnoldswick – A request has been received from the Site Supervisor of Gisburn Road Primary School for the existing school entrance markings to apply at any time rather than the current Mon-Fri 8am-6pm, and a request for an additional set of markings outside the entrance opposite no. 43 Leonard Street.

TLM agreed not to proceed with an extension to the times of the existing school entrance markings and to carry out a site visit to see if new restriction are required for entrance opposite no. 43 Leonard Street and to report back to a future meeting.

5.5. **Lord Street, Colne –** A request has been received for new school entrance markings on Lord Street to cover all three pedestrian entrances to the school. Also to amend the existing markings on Fothergill Street to only

include one set of markings outside the entrance around the middle of Fothergill Street

TLM agreed that LCC would carry out a site visit at school opening and close times and bring back to next meeting

#### 6. Speed / Traffic Concerns

#### 6.1. Speed Calming Measures - Chapel House Road, Nelson.

SW advised the group that Nelson Area Committee Members continue to be concerned about the speed of traffic on Chapelhouse Road. MH advised that LCC have previously provided quotes for a scheme and advised the Pendle Members that as this is an amenity scheme it would not meet the criteria for LCC to provide any funding and that full costs for any scheme, including any further investigatory work would have to be met by Pendle or Nelson Town Council.

TLM Agreed that this matter would be reported back to Nelson AC for their Members to make a decision on any potential further investigation and funding.

#### 7. Developments

- 7.1. **Outstanding S106 Projects -** SW advised the group of two outstanding S106 projects with upcoming spend deadlines, these are :
  - Land at Filter House Barley Green £600. For traffic calming measures within the village
  - Pendle Court Developments £6,000. For upgrades to the bus stops on Scotland Rd adj. to petrol station and o/s 156 Scotland Rd.
     MH said he would check with LCC colleagues and update SW outside of the meeting.

#### 8. Pendle Borough Council items

8.1. **Road Closures at school drop-off/pick-up times –** A request has been made by Pendle Council' West Craven Area Committee for LCC to undertake a pilot scheme for a school of their choice in West Craven, to see if there were benefits from streets around it being closed at drop-off/pick-up times.

MH advised that group that this has been tried elsewhere without success. Also that the Traffic Management and TRO costs make this unsustainable. LCC are not looking to do this again.

TLM Agree – no further action

8.2. **Springfield Avenue, Earby** – A request has been made for the school entrance markings in the turning circle on Springfield Avenue to be removed. The group agreed that it would appear that they are not required.

# TLM agreed that LCC would write to the school to confirm that they are happy for the markings to be removed.

#### 9. Police

- 9.1. GM advised the group of an ongoing road safety initiative. Ther are currently traffic counters in Nelson and Colne. The results of this will be reported to a future meeting.
- 9.2. GM asked the group following reports he'd received regarding vehicles jumping the lights on both Vivary Way and Langroyd Road for the groups views on this. It was agreed that there is a problem in both locations. GM reported that across Lancashire there's a will to get cameras put on these 'hot spots' to be able to detect offenders. The TLM agreed that support from Pendle Council Members both via these minutes and separately to the Police and oad Safety Partnership would all bolster support to have cameras introduced at these locations.
  TLM agreed that Pendle Councillors should be asked to support this

ILM agreed that Pendle Councillors should be asked to support this initiative.

#### 11. Any Other Business

11.1. Wheatley Lane Road – MW advised the group of the recent second informal consultation on Wheatley Lane Road for proposed restrictions on north west side and at 374 to 384 and 340 to 342 and south east side from 343 to 349 and 331 to 335 and junction protection outside 359 Wheatley Lane Road. The second informal consultation has just been completed. Residents have asked for double yellows on the full south east side which it was agreed would only increase the speeding in this area. It was noted that both the Bus Services and the winter maintenance teams support the suggested restrictions.

LCC to review the comments form the second consultation. TLM agreed to the proposal subject to this review.
