# 16. THE LICENSING ACT 2003 – REVIEW OF A PREMISES LICENCE PAPAS PIZZA, 144-146 LEEDS ROAD, NELSON, LANCASHIRE, BB9 9XB

The Planning, Economic Development and Regulatory Services Manager submitted a report for Members to consider an application made by Pendle Borough Council (Licensing) to review a Premises Licence for Papas Pizza, 144-146 Leeds Road, Nelson under the Licensing Act 2003.

Three representations had been made by interested parties (being local residents) under the 'Prevention of Crime and Disorder', 'Public Safety', 'Prevention of Public Nuisance' and 'Protection of Children from Harm' licensing objectives.

## <u>Licensing Committee</u> (29.11.2022)

The Members and all relevant parties had received a copy of the report which included a copy of the application and the representations received.

The applicant, Wajed Iqbal of Pendle Borough Council (Licensing) attended the meeting. The hearing was also attended by Mr Mohammed Sharaz of Papas Pizza, accompanied by Nasar Mahmood and Rabnawaz Khan.

Also in attendance were Mr Abaid Hussain and Mr Tanveer Akhtar who had made representations.

## **RESOLVED**

- (1) That, having listened to the representations made with regard to the application to review the Premises Licence in respect of Papas Pizza, 144-146 Leeds Road, Nelson it be agreed that
  - the timings for late night refreshment remain as Monday to Sunday 23:00 to 00:00 for the premises licence numbered PEN(N)0381 granted to Papas Pizza, 144-146 Leeds Road, Nelson;
  - condition C1.1 be amended to state:-
    - "All delivery drivers must park their vehicles on either St. Phillips's Street adjacent to the church (not on the residents' side), Harvey Street or any nearby car park.";
  - conditions C1.4 and C1.5 be removed from the premises licence.
- (2) That Lancashire County Council be requested to increase the parking patrols in this area and take enforcement action where necessary.

## REASON

Consideration has been given to all the powers available to the licensing authority under section 52(4) of the Act and concludes that the amendment/deletion of conditions on the licence is both necessary and proportionate in the circumstances.
