23/0475/VAR Variation of Condition: Vary Condition 2 (Plans) of Planning
Permission 22/0399/HHO at 56 Carr Road, Nelson for Mr Hussain

At a meeting of Nelson, Brierfield and Reedley Committee on 4<sup>th</sup> September 2023 the decision to approve this application was referred as a recommendation to this Committee as the design was contrary to the guidance of the Design Principles SPD and Conservation Area Design and Development SPD and would represent a significant departure from policies ENV1 and ENV2 of the Core Strategy.

23/0425/FUL

Full (Major): Erection of 1 no. industrial building split in 2 no. units with Mixed Use Class E(g), B2 (Industrial) or B8 (Storage or Distribution) on Land North East Of Vantage Court, Riverside Way, Barrowford for Barnfield Contractors UK Ltd

At a meeting of Barrowford and Western Parishes Committee on 6<sup>th</sup> September 2023 the decision to refuse this application on the grounds of parking issues was referred as a recommendation to this Committee as the development does not raise any potentially unacceptable highway safety impacts or parking issues and LCC Highways have no objection to the scheme. This would result in a vague, generalised reason for refusal which could not feasibly be defended at appeal and would result in a significant risk of costs being awarded against the Council.
