#### **HIGHWAYS ISSUES**

#### 8. <u>Proposed footpath improvements, Myrtle Grove, Barnoldswick</u>

At the last meeting, as requested, the Council's Engineering Team provided a plan and costings for footpath improvements from Myrtle Grove across the fields to Barnoldswick Church of England Primary School to encourage more parents to walk their children to School. However, it was confirmed that LCC would not allow part of the land adjacent to Myrtle Grove to be used as it was reserved for educational use.

It was resolved that LCC be asked to arrange for the unmarked but well used footpaths in this location to be added to the definitive map. LCC has replied with the appropriate application forms and guidance notes, stating that evidence is required to show that a route is a public right of way and then, on the strength of that evidence, an application can be made for a Definitive Map Modification Order.

County Councillors for Pendle Rural have been invited to this meeting to discuss this issue with Members.

#### MISCELLANEOUS ITEMS

#### 9. <u>Request for Improvements to back streets in Barnoldswick Town Centre</u>

At the last meeting it was reported that Pendle Council's Chief Executive and Director of Place had met LCC Highway Managers on site to see if the highway authority would resurface prominent back streets in Barnoldswick town centre, in particular Back Frank Street and Back Albert Road. It was pointed out that as well as aesthetic reasons, there was a safety aspect to carrying out the necessary work as there were trip hazards to residents and pedestrians. LCC officers in attendance felt that resurfacing these roads was not a key priority and said that this would be confirmed in writing.

County Councillors for Pendle Rural have been invited to this meeting to discuss the issue with Members.

### 10. New Road Community Centre, Earby

A meeting is being held on 25<sup>th</sup> September with the management of New Road Community Centre to discuss bookings and hiring of this community facility. A verbal update will be given at the meeting.

### 11. Local Cycle and Walking Infrastructure Plans Engagement Stage 2

LCC have prepared Local Cycle and Walking Infrastructure Plans (LCWIPs) showing proposed Active Travel Network Maps across Lancashire.

Pendle Council has been working with LCC on the Burnley and Pendle LCWIP. Comments are now being sought from the public on the proposed network plan.

The initial public engagement, Stage 1, took place last year. The link below gives details of the routes in the area and across Lancashire and comments are welcomed -

The consultation closes on 24th October 2023.

#### 12. Items for Discussion

It has been requested that the following item be discussed –

# (a) New Cut and Wentcliffe Beck watercourses at Earby becoming choked with debris and vegetation

There is concern that a considerable amount of debris and vegetation is at risk of blocking the above two watercourses at Earby. Pendle Council officers have raised this issue with the Environment Agency. Any update will be reported at the meeting.

# (b) Land off Bailey Street, Earby

To consider the temporary use of this land for PEARL Together to use during construction work at Spring Mill, and the request for future maintenance of public open space at the development.

# (c) Land at Cornmill Place, Barnoldswick

At the last meeting Committee decided not to proceed with taking ownership of this land, as it appeared that responsibility for highway maintenance would be involved. Subsequent enquiries have confirmed that the highway is maintained by the highway authority. Committee is asked to reconsider this matter.

# (d) Salterforth Road, Earby and Manchester Road, Barnoldswick

To consider the damage being caused through defective drainage systems on these roads.
