

## 7. Area Committee Budget 2023/24

- Bid from the Kelbrook and Sough Village Hall Committee requesting £440 towards the installation of solar panels on the roof of the village hall
- Bid from Earby and Kelbrook Senior Citizens' Club seeking £1,500 towards a new boiler. This bid was considered at the meeting on 4<sup>th</sup> July when it was deferred and the Club were encouraged to apply for Awards for All National Lottery funding.

## **HIGHWAYS ISSUES**

## 8. Salterforth Road, Earby Highway Drainage

At the 3<sup>rd</sup> October meeting Members requested action to address drainage issues on Salterforth Road Earby and Manchester Road, Barnoldswick.

On Manchester Road, contractors have recently dug down and repaired the blocked culvert. However, on Salterforth Road, following unsuccessful attempts to clear the blocked drain by jetting, LCC officers have agreed to dig down to sort out the blockage, but this work is still outstanding. Two potholes have been filled in but the new bitmac is breaking up and coming out due to water welling up. Shallower potholes about 2" deep have not been filled. The damaged surface extends for over 30 metres along the road from one kerb to the other.

## 9. Meeting with Transdev

**Enc.** On 13<sup>th</sup> November Members were invited to a Teams meeting with Mr P. Turner, Commercial Director at Transdev and J. Kelly, Trainee Engineer at Pendle Council to discuss bus services in West Craven. Attached is a note of the meeting.

## 10. Spring Mill, Bailey Street, Earby

PEARL Together has purchased the former Spring Mill site in Earby, and intends to redevelop the site for residential use, to construct 53 units.

At the Executive meeting on 16<sup>th</sup> November, it was agreed that PEARL Together would be granted a licence for the temporary use of land on Bailey Street, Earby for use as a contractor car park/compound during the development of the site. It was also agreed that a landscaped area would be created as part of the development scheme, fronting onto Chapel Street, Earby, which would be transferred to the Council subject to terms and conditions to be agreed by the Director of Place and payment of a commuted sum.

The Executive requested that this Committee enter into discussions with Earby Town Council and any other interested parties to consider an alternative use for the compound area once it is no longer needed and that the developers be advised that the reinstatement of this land may be for something other than a grassed area.

## National Powergrid Substation (Northolme 2025) on Warwick Drive, Earby

Enc. There has been a complaint by a resident living on Warwick Drive about the condition of the substation operated by Northern Powergrid. Some years ago, the power company constructed a new substation housing in front of the existing one. However, this hasn't been brought into use and remains fenced off with temporary site fencing. Operational Services have reported the matter. Any update will be reported at the meeting.
