1. Declaration of Interests

A Member must declare a disclosable pecuniary interest which he/she has in any item on the agenda. A Member with a disclosable pecuniary interest in any item may not participate in any discussion of the matter at the meeting and must not participate in any vote taken on the matter at the meeting.

In addition, the Council's Standing Orders require a Member with a disclosable pecuniary interest to leave the room where the meeting is held while any discussion or voting takes place.

4. Strategic Leisure Review

At the last meeting of this Committee, Members were advised that a team of consultants, led by Alliance Leisure, had been engaged to work on a review to examine how the three leisure facilities in Colne, Nelson and West Craven could be made to be financially viable through retrofitting and renewal; to consider the mix of features taking affordability into account; and to consider operating models for the future taking account of what was needed to ensure delivery of requirements for each leisure facility.

The Committee is invited to consider and comment on the findings of the review (**report to follow**), compare these with the findings of the most recent feasibility study carried out by Knight, Kavanagh and Page (KKP) (accessed via the following link: https://www.pendle.gov.uk/meetings/meeting/3247/overview_and_scrutiny_committee), and make recommendations to the Executive.

The meeting will be attended by representatives from Alliance Leisure and KKP who will both give a short presentation. The Chief Executive of Pendle Leisure Trust will also be in attendance.
