- **Climate Emergency Action Plan.** The Climate Officers Working Group is currently developing the PBC Climate Action Plan, the resource implications of which will be finalised following the Council budget meeting in February.
- **Review of Climate Emergency Working Group's Terms of Reference and Membership.** The CEWG Terms of Reference has remained unchanged since 2019. It is now proposed the Executive consider reviewing the Terms of Reference, including membership, at a future meeting to ensure the Terms of Reference remain fit for purpose.
- **North West of England Community Energy Fund.** North West Net Zero Hub is administering our regional share of the national Community Energy Fund (CEF) a national £10Million grant programme for community groups and eligible third sector organisations to develop projects from feasibility to commercialisation. The funding will support eligible community groups to consider options, design schemes and overcome barriers to investment. It should be noted that it will not provide a grant for capital investment in the projects themselves. www.localenergynw.org/page/community-energy-fund
