### 5. Parking Concerns / Requests for Restrictions

5.1. **Rear of Linden Road, Colne** – Request from CC Sutcliffe for parking restrictions or other measures to be placed at the Cragg Street end of the back street of Linden Road. Reports vehicles parking between the residents parking permit bays which is obstructing the gated back street for pedestrian access.

TLM agreed – LCC to provide a H-bar marking as parking restrictions were not supported.

### 6. Speed / Traffic Concerns

GM reports that a speed camera outside The Oaks in Brierfield has been approved. Various speed reduction work being considered. GM reports ongoing concerns with speeding from Burnley to Nelson through Brierfield, particularly Manchester Road.

### 8. Pendle Borough Council items

 8.1. Every Street, Nelson – PBC Leader requesting priority system between Moseley Street and Macleod Street. Request for this section to be made one-way was previously declined due to disruption of local traffic and likely speed increases.
TLM agreed – no support for priority system. MW to inspect the

existing junction markings as they appear to be incorrect.

8.2. A56 Colne to Earby – request for average speed cameras following a recent incident involving a vehicle at high speed around the boundary between Earby and Sough. Members discussed that the route may not be suitable for treatment by average speed cameras as there are many junctions where vehicles may turn off the route. GM advised all current funding for average speed cameras has been allocated. TLM agreed – no further action at this time, however LCC and LRSP could work to try to identify any possible action.

### 9. Police

Lancashire Road Safety Partnership is being dissolved. Ongoing speeding reports still being processed through the website by the police.

## 10. LCCHQ

CGL advised of the Accessible Nelson scheme, in particular any changes to the electric vehicle charging infrastructure provided by BP Pulse. Further discussion to be had as this develops.
