### 4. Enforcement Action

**Enc.** The Assistant Director Planning, Building Control and Regulatory Services submits the attached report on the following enforcement case for determination -

**PLE/23/0058      Enforcement Notice: Unlawful Erection of a Fence at 59 Marsden Hall Road, Nelson**

At a meeting of Nelson, Brierfield and Reedley Committee on 5<sup>th</sup> February the Committee made a resolution for enforcement action not to be taken in the case at 59 Marsden Hall Road requiring the owner of land to remove the side facing fence. Before they voted on that resolution, they were advised that the decision not to take enforcement action would represent a significant departure from policy, contrary to the decision the Council had previously taken to issue an enforcement notice which was then upheld at appeal. It would therefore be referred to the Head of Legal and Democratic Services and subject to his agreement the decision would stand referred to this Committee.

The Head of Legal and Democratic Services advises that in this case, it would be a significant departure from Council policy ENV2 not to prosecute or otherwise enforce breach of the enforcement notice in these circumstances.
