## **5. Parking Concerns / Requests for Restrictions**

- 5.1. **Waidshouse Road, Nelson – parking issues.** Enquiry to PBC from public regarding speeding issues/pedestrian movements to/from nature reserve. No collision history to support safety issue. Traffic Team & PBC to monitor area further and carry out site visits at varying times of day. Vehicular traffic count could potentially be proposed on stretch of Waidshouse Road around entrance to car park for nature reserve.
- 5.2. **Harrison Drive, Colne – priority change and parking issues -** Change in priority at the first throttle on Harrison Drive north of North Valley Road gyratory. Change relating to new development and expected increase in vehicular traffic. Reported possible parking issues around the throttle. Traffic Team to monitor parking at site in terms of potential introduction of parking restrictions around throttle. K.H informed group that these works could be carried out by Barnfield Construction under section 278 works if deemed necessary.

## **6. Speed / Traffic Concerns –** No speed/traffic concerns to report.

## **7. Developments –**

- 7.1. **Bradley Road East, Nelson -** Introduction of LWB outside children's nursery to be formally advertised in upcoming TRO Countywide Order with aim of assisting with drop-offs. Plans to convert old baths into car sales/workshop & cash and carry, along with plans for another car sales/workshop premises south-east of nursery. Can existing TROs be revived/alterd/kept and pedestrian improvements made within planning costs. Former terraced housing areas stopped up but still in adopted layer on LCCs mapping system, S.W to locate section 247 records and pass on to M.H for Asset Team to update maps. DPB on Caleb Street also to be revoked.
- 7.2. **Halifax Road, Nelson –** planning application in for new wedding venue with enough car parking spaces on site and plan to extend 30mph speed limit up to venue entrance and add traffic calming measures and speed gateway to match existing speed humps. Traffic requesting to see plans for this but there are no issues regarding the proposal from the group. Only opposition to proposal coming from residents on the Burnley side of area due to concerns of road suitability on approaches to the venue.

## **8. Pendle Borough Council items –**

- 8.1. **Accessible Nelson** update provided, start date for LCC looking like towards end of 2024.
- 8.2. **Clitheroe Road, Brierfield –** scheme to replace existing speed cushions preferably with 6m flat top plateau humps to be paid for by Brierfield Town Council. PBC asked for copies of previous drawings LCC may hold with these humps for plans to be drawn up as it's showing as a bus route.

## **9. Police –** nothing to report. K.H advised construction of new Police Hub off the M65 has begun, with advice on large crane being sought and not currently causing any issues.

**10. LCCHQ** – CGL has asked if future TRO plans for accessible Nelson scheme can be sent to Traffic Order Team 8 months prior to any works commencing to help with scheduling.

**11. Any Other Business** – nothing to report.
