223. PLANNING APPLICATIONS

(a) Applications to be determined

23/0750/ADV Advertisement Consent: Display of 1 no. fascia sign at Primet Business Centre, Burnley Road, Colne for Mr James Knowles

That consideration of this application be **deferred** to allow for discussions with the site owner on standardising the signage for businesses on the site with the aim of achieving acceptable forms of advert in a conservation area.

24/0108/FUL Full: Erection of 5 no. motorhome pitches and the change of use from a single storey lean to, to form a toilet and shower block at Piked Edge Farm, Skipton Old Road, Colne for Mr and Mrs Swales

RESOLVED

That planning permission be **refused** for the following reasons –

1. The application site is in a location with low accessibility that would not be readily accessible by public transport and sustainable modes of transport and the proposed development, it would not be conveniently accessible to users and would result in an unacceptable increase

in car usage contrary to policies SDP2, WRK5 and ENV4 of the Pendle Local Plan Part 1: Core Strategy.

- 2. The use of Skipton Old Road by pedestrians from the site would result in an unacceptable risk to their safety contrary to policy ENV4 of the Pendle Local Plan Part 1: Core Strategy and paragraphs 114 and 115 of the National Planning Policy Framework.
- 3. The proposed development would be prominently visible from the adjacent public right of way and in the wider area and would thus result in harm to the rural character of the countryside and thus the visual amenity of the area contrary to policies ENV1 and ENV2 of the Pendle Local Plan Part 1: Core Strategy.

(b) Planning applications for comment

The Assistant Director, Planning, Building Control and Regulatory Services submitted a report which invited comments on the following planning application –

24/0061/FUL Full (Major): Change of use of agricultural land to a designated local nature reserve at Gib Hill, Gib Hill Road, Nelson for the Borough of Pendle

This application was for a development which straddled the boundary with this Committee and the Nelson, Brierfield and Reedley Committee and, as such, must be determined by the Development Management Committee. The application was brought before Committee for comment.

RECOMMENDATION

That the Development Management Committee be advised of this Committee's full support for the application, be recommended to **approve** the application and in doing so recognise that –

- The change of use of this land to a designated local nature reserve would be of great educational value to the schools that border the site.
- The site's flora was of great value and that consideration could be given to restricting open access to some parts of the site to support its conservation.
- Crops of hay could be taken off the site.
- The designation of this site would double the acreage of nature reserve in the borough.
- The site would continue to form a natural boundary between Nelson and Colne, ensuring that the towns kept their own identity.

(c) Planning appeals

The Assistant Director, Planning, Building Control and Regulatory Services submitted a report on planning appeals.

It was verbally reported that an appeal against refusal of permission for the display of a single wall-mounted 6x3 metre LED display unit at 66 Market Street had also been received.

227. PREMISES IMPROVEMENT GRANT SCHEME – SUMMARY 2023/24

The Head of Economic Growth submitted a report which updated the Committee on the progress made on the Colne Premises Improvement Grants Scheme in 2023/24. An additional funding allocation was requested to allow the programme to continue. The Committee was also asked to nominate a minimum of two members to the Grant Panel for 2024/25.

An update was provided on the work and activities of the Colne Youth Action Group (CYAG). This included an update on progress with works to the Youth Hub.

An update on progress with the Colne Levelling Up Fund (LUF) projects was submitted for information. The projects consisted of the Heritage Quarter (the Muni Theatre, Little Theatre, and Pendle Hippodrome) and the Colne Market site.
