# Flooding Issue on Red Lane, Blacko

Lancashire County Council (LCC) have attended Red Lane, Blacko and have identified a blocked private drainage ditch/culvert which is preventing the gully outfall pipe from working as it should. LCC have since written to the landowner highlighting the need to clear the outfall pipe to resolve the issue and will revisit to check they have made progress with this.

# Flooding Issue on Stang Top Road, Roughlee

LCC need to undertake a CCTV drainage survey to ascertain why some of the gullys on Stang Top Road, Roughlee are not running at the junction of Blacko Bar Road and will be programming this work in due course.
