3. Planning Applications

Enc. The Assistant Director Planning, Building Control and Regulatory Services submits the attached report on the following planning applications for determination –

(a) 24/0247/VAR Variation of Condition: Vary Condition 2 (Plans) of Planning Permission 22/0197/FUL on land to the north east of Saint Thomas Church, Wheatley Lane Road, Barrowford

At a meeting of Barrowford and Western Parishes Committee on 10th July 2024 the decision to refuse this application for the reasons set out below was referred as a recommendation to this Committee as the decision would represent a significant risk of costs to the Council.

- (1) Plot 1 being closer than 21m from an existing dwelling (Oaklands Lodge) it is 20m away.
- (2) Impact on heritage and the "additional less than substantial harm" to the character and appearance of the Conservation Area.
- (b) 24/0267/HHO Full: Erection of a front and rear dormer to facilitate a loft conversion and a first-floor rear extension at 119 Clayton Street, Nelson

This application was deferred from the last meeting to allow the applicant to have discussions with Planning and submit amended plans with a better design addressing the residential amenity issues, and that was more in proportion and in keeping with the area.
