5. Parking Concerns / Requests for Restrictions

- 5.1. **Commercial Road, Nelson.** Reported problems with vehicles parking close to the entrance to the driving test centre as well as on the opposite side, causing visibility and access issues. Request for new double yellow lines to be instated on either side of the entrance as well as increased enforcement of the existing restrictions on the opposite side. All in attendance agreed for **LCC Traffic** to go out to informal consultation for new double yellow lines outside the entrance. **LCC Traffic** also to report the non-compliance issues on the restrictions on the opposite side to LCC Parking Services for additional targeted enforcement.
- 5.2. **Victory Road, Nelson.** Reported by residents via CC Iqbal, issues with parked vehicles causing access issues for residents of Victory Close and requesting a residents permit parking scheme for the street. MI confirmed that the street would not meet the criteria for a permit parking scheme due to the availability of off-street parking for residents. All in attendance agreed for **LCC Traffic** to go back to CC Iqbal to clarify the parking issues and to propose double yellow lines if a scheme can be found to be palatable and proceed to informal consultation with residents.
- 5.3. **Charles Street, Nelson.** Request for parking restrictions to protect the vehicular access to the allotment gardens between nos. 101 and 103 Charles Street, Nelson. All in agreement for **LCC Traffic** to proceed with an informal consultation for double yellow lines for a short distance both sides to improve vehicular access.
- 5.4. **Bridge Street and Shaw Street, Colne.** Reported parking and access issues. Following an informal consultation for proposed single yellow lines to allow for better daytime traffic movements, multiple objections were received from the businesses off Bridge Street. Main points of objection include that the restrictions could stop customers from using the businesses and parking would be displaced to a location away from their CCTV. All in agreement for **LCC Traffic** to go back to the CC who raised the initial concerns and also to speak to the LUF team with regards to the extents of the upcoming LUF scheme in this area.

6. Speed / Traffic Concerns

- 6.1. **A56 Kelbrook and Earby.** Re-raised issue with vehicles speeding along this route following a collision around September 2023. GM notes that although the collision may have appeared to have been serious it did not result in any injuries. Additionally, a toucan crossing has been requested in Sough to connect the bridleway across Colne Road. **KH** to check any available data to support this request.
- 6.2. **Wheatley Lane Road, Fence.** Reported speeding issues along the section between Fence and Barrowford. **GM** advised that the police would utilise their 'armadillo' unit to gather evidence and report back.

7. Developments

- 7.1. **Greenfield Road, Colne.** Vehicles have started to use the section between Colne Road and Whitewalls Drive as a gate and Prohibition of Driving signs have been removed in relation to the nearby development. **PBC** to replace the gate and **LCC DC** to replace the Prohibition of Driving signs.
- 7.2. **Charles Street, Nelson.** Request to implement a one-way order on Charles Street travelling westbound. **PBC** to feed back to other teams involved for consideration within planned local improvement schemes.
- 7.3. **Carr Road, Nelson.** Proposed new development for the land on the north side between Pendle Water and the M65 bridge. **LCC DC** seeking to implement traffic calming features in relation to ongoing reports of speeding along this section. Awaiting feedback from the Bridges team before any further consideration can be given.

8. Pendle Borough Council items

- 8.1. **Marsden Hall Road South, Nelson.** Proposed new development on the south end of Marsden Hall Road South. Gates were provided to prevent unauthorised access to the land due to isolated reports of antisocial behaviour. Gates to be removed as part of the development. **LCC DC** requesting potential extension of existing traffic calming measures to pre-empt further speeding issues. **LCC Traffic** to check for previous reports of speeding in this area.
- 8.2. **Livingstone Walk, Nelson.** Reports of vehicles blocking access to Livingstone Walk at the south end where it meets Chapel Street. **LCC Traffic** to take to informal consultation for parking restrictions.

9. **Police** – nothing to report.

10. **LCCHQ** – nothing to report.

11. Any Other Business

- 11.1. Marsden Hall Road North, Nelson. Issues with parking and traffic around Castercliffe primary school during drop-off and pick-up times. Reported by a Police Constable from Nelson Police Station. **LCC Traffic** to provide a response to GM to pass on.

12. **Provisional date of next meeting** – last week in August or first week in September depending on availability.
