1. Welcome and to receive any apologies for absence

Councillor David Whipp welcomed everyone to the meeting, thanked them for their attendance and requested to introduce themselves.

2. Minutes from last meeting

The minutes of the last Pendle Community Safety Partnership held on 16th October 2023 were approved as a correct record.

3. Domestic Homicide Review (DHR) update (Tim Horsley)

- 1st DHR Overview Report has been published on the Community Safety Page of the Council's website
- 3rd DHR Notification the Coroner has notified this as an accidental death so there will be no further action
- 4th DHR Notification is awaiting update from Police
- 2nd DHR the Overview Report is nearly complete. Because the Review Panel has recommended the report will not be published due to the sensitivity around the case, the Partnership **agreed** a Special Meeting led by the Chair with representatives from the Responsible Authorities who sat on the Review Panel be held to approve the report to be sent to the Home Office.

4. Updates:

The **Police MATAC Report** was presented by the Neighbourhood Police Inspector and Sergeant

- Burglary there has been one local arrest and three arrested having travelled from West Yorkshire resulting in a significant reduction in the last month
- Vehicle offences there has been one key arrest
- Robbery there has been one key arrest
- There has been an increase in stalking offences which may appear in the next report
- Domestic Abuse was up in the last 28 days
- Violence against the Person is up specifically in Southfield as well as generally
- ASB in North Valley has settled during Operation Centurion
- A knife surrender bin has been located outside Nelson Police Station

Colne Community Safety Working Group

The Groups attendance has risen dramatically over the last three months, now averaging some 22 per meeting. Various national and Lancashire reports have recently highlighted the importance of such groups in keeping the NPT aware of resident issues and avenues for Investigation. The other centres in Pendle need to find volunteers to set up similar groups to match the work that we are doing.

The NPT have worked prodigiously in Colne recently and this is having a demonstrative effect on crime figures. Sergeant Emmett should be proud of his team.

- Ellesmere Avenue Residents raised drug related issues with the group and the NPT have made four arrests and three charged
- Tagged graffiti is proliferating in the town causing problems and costs to both business and PBC.

Lancashire Fire and Rescue Service - successful Brightsparx campaign in November with relatively low activity and ASB related activity low generally

Inspire – concern about a continuing increase in substitute opioids and a recent death locally

5. Pendle Community Safety Partnership Plan 2022-25

Prevention and early intervention

- Domestic Abuse (Pendle Domestic Abuse Forum) a partnership workshop was held in December to look at how the Forum works and how the action plan can be updated in a practical and sustainable way
- Child Exploitation (Burnley & Pendle Exploitation Awareness Group) under review
- Youth Anti-Social Behaviour (Pendle Youth Forum) the case management Youth Panel met for the first time in November

Crime prevention

- Serious Violence and the Serious Violence Duty Pendle has joined with the Pennine CSP in a Joint Steering Group around the Strategy and Delivery
- Serious Organised Crime (Pendle and Ribble Valley Genga Panel) a Clear, Hold, Build approach is being considered in Brierfield and Nelson however the Panel is currently under review and on hold
