### 8. Groundwater problems at Wentcliffe Drive, Earby

A report was submitted to the Council's Policy and Resources Committee on 16th March 2023 outlining the likely issues that have caused the ongoing groundwater problems at Wentcliffe Drive. At that meeting it was -

#### **RESOLVED**

- (1) That further discussions be held with representatives from Together Housing, Lancashire County Council and the Environment Agency with regards to the impact of the groundwater problems being experienced by residents.
- (2) That the residents be advised to contact their own insurance companies in relation to the damage the groundwater problems have impacted on their properties.

Following the meeting, attempts were made to encourage parties whose assets have been affected to pursue action against Together Housing. No further progress was made.

A scheme was implemented to alleviate some of the problems where groundwater was flowing over the footway and caused hazardous conditions in winter (outside 7-13, 17-21, 27-31 and 30 Wentcliffe Drive).

The matter is included on the agenda to try and progress the issue.

# 9. Future Maintenance of Sough Park

At the request of this Committee a meeting was held on 25<sup>th</sup> September to discuss the future maintenance of Sough Park. Representatives from Kelbrook and Sough Parish Council, Kelbrook Phoenix FC and Sough Bowling Club attended along with some Members of this Committee, the Assistant Director Operational Services and the Green Spaces Manager.

The purpose of the meeting was to set out the history of the transfer of facilities including financial arrangements for the maintenance of the park, playing fields and memorial gardens located within the boundaries of Earby and Kelbrook and Sough.

The bowling club had taken over maintenance of the greens with support from Operational Services Parks Team. They advised they would continue to maintain the greens for the foreseeable future and had plans to open a tuck shop in 2025.

Kelbrook Phoenix FC reported they would continue to maintain pitches and the pavilion's changing areas for the remainder of the season.

Both clubs received advice on areas to seek support in raising funds.

Kelbrook and Sough Parish Council and Kelbrook Phoenix FC representatives reported difficulties in obtaining funding due to the pitches remaining in the ownership of PBC and restrictions placed on the fields (by fields in trust).

#### **Proposed Actions**

- Operational Services to provide maintenance schedules with costs showing top class, middle class and basic level of maintenance to this Committee and Kelbrook and Sough Parish Council for discussion. The Parish Council were meeting on 17th October.
- Further meeting to be arranged to allow the group to discuss maintenance arrangements further. Earby Town Council to be invited to the next meeting.
- That this Committee concentrate remaining funds for Earby on maintaining the memorial gardens to ensure the facility does not go into decline.

# 10. <u>Update on Youth Work in Earby</u>

The Children and Family Wellbeing Service report that unfortunately, at this time they do not have the capacity to commit to establishing a universal youth service in Earby. However, targeting the Detached Youth Work offer and reviewing their commitments is something they do regularly and engaging with partners to be clear about the community need, so they hope that in time they will be able to revisit this.

- (c) Tree Preservation Order, Land off Salterforth Road, Earby Order has been served. An update will be provided after the period for representations has elapsed.
- (d) Virgin Media works, Earby Update requested
