9. Town Boundary Signs

Enc. In response to a request of this Committee, Lancashire County Council (LCC) has been asked to further consider the Committee's suggestions for supplementary wording to the town boundary signs.

Members' attention is drawn to the attached report, which was considered by the Committee in March 2023, and are advised that LCC's position remains the same, in that any sign on the highway must comply with the Traffic Signs Regulations and General Directions (TSRGD).

The report details the options available at that time for boundary signs to be situated on the public adopted highway and these are still the only options for any new boundary signs.

Where it seems that other Councils have more freedom in terms of what they can put on their signs, it may be that these were not actually situated on the public adopted highway, but in close vicinity.

The Committee should be minded to pursue the options detailed within the report dated 30th March 2023 or not take the matter further if these options would not meet the Committee's objectives.
