## 5. Parking Concerns / Requests for Restrictions

- 5.1. **Earby Road, Salterforth.** Repeat reports of vehicles parking between Sykes Close and the blind bend before Klondike Hill. Residents report that vehicles parked on the north side result in eastbound vehicles being on the wrong side of the road when approaching the bend, resulting in westbound vehicles occasionally leaving the carriageway and colliding with property. There are yellow-backed warning signs present on both approaches which indicate the presence of the bend and pedestrians in the carriageway due to the lack of footways around the bend. Request is for double yellow lines to be provided on both sides between the bend and Sykes Close. All in attendance agreed that LCC should take the requested proposal to informal consultation to gauge local support.
- 5.2. **Spring Mill Court, Fence.** Reports of vehicles parking on both sides of Pendle Lane between the junction with Wheatley Lane Road and the vehicle entrance to Spring Mill Court, causing access issues for residents. Photos send in by residents showing vehicles parked on both sides leaving significantly restricted carriageway width for vehicles to pass. All in attendance agreed that LCC should proceed to an informal consultation for double yellow lines on the west side of Pendle Lane between Wheatley Lane Road and Spring Mill Court including the vehicle crossing to Spring Mill Court.

### 8. Pendle Borough Council items

# 8.1. Action arising from West Craven Committee 06.08.24.

#### (1) That the Committee's previous request for average speed cameras along the A56 from the Langroyd in Colne to the Punch Bowl in Earby be reconsidered.

GM suggests that Cllr Whipp should push for the average speed camera proposals to be expedited. It is likely that the proposals will go ahead but expected to take some time.

# (2) That consideration be given to reducing the speed limit in built up areas along the A56 to 20mph.

There is no support at this time to introduce blanket 20mph speed limit orders in the built-up areas along the A56. Issues relating to speeding should continue to be reported and handled on a case-by-case basis through the correct channels. (3) That more information be provided on the request for a toucan crossing in Sough to connect the bridleway across Colne Road.

LCC Development Control have requested a pedestrian crossing at this location in relation to the new proposed housing development on the east side of the A56.

(4) That LCC be asked to review the road classification of Coates Lane, to allow the width of the carriageway to be reduced, thus enabling the central line on Skipton Road to be moved further towards the left hand side which would move emerging vehicles to the left, to improve visibility, and

(5) That LCC's Operations Engineer be asked for an update on the possibility of painting white hatch markings at the centre of the junction of Coates Lane/Skipton Road.

Investigations have previously been carried out with regards to adjusting the junction markings, alongside the possibility of additional hatching, to improve visibility for vehicles turning out of Coates Lane onto Skipton Road. PBC to reassess and provide LCC with proposals. There is no support for the reclassification of Coates Lane.

#### 10. LCCHQ

- 10.1. The amended Colne C12 residents permit parking order will be sealed and enforceable in the immediate future.
- 10.2. Accessible Nelson scheme to commence in the near future. MW to contact the construction team to clarify timescales with relation to TRO changes.

- 11.1. SW seeking funding to progress a new 20mph scheme in Trawden. Plans to be provided to LCC who will draw up a proposal and bring to next Pendle TLM.
