81. PLANNING APPLICATIONS

(a) Planning applications for determination

The Assistant Director Planning, Building Control and Regulatory Services submitted the following planning applications for determination: -

24/0366/FUL Full: Demolition of existing mill building and the erection of a 2.5 storey apartment building to accommodate 6 no. apartments and associated site works at Sandy Lane Business Centre, Sandy Lane, Barrowford for Premier Vue

Determination of this application had been deferred from the last meeting of this Committee to allow for the information provided in an update report and amended plans to be fully considered.

RESOLVED

That planning permission be **refused** for the following reason: -

The application site lies in the Newbridge Character Area as designated in Barrowford Neighbourhood Plan Policy BNDP 10. The scale, form and design of the proposal is out of scale and character with the area and as such represents poor design. The development would thus be contrary to adopted Policy BNP 10 of the adopted Barrowford Neighbourhood Plan, Paragraph 139 of the National Planning Policy Framework and policy ENV 2 of the adopted Part 1 Pendle Local Plan - Core Strategy.

24/0484/FUL Full: Demolition of existing vacant shop and the erection of 6 no. dwellings with associated infrastructure at Roaming Roosters, Barrowford Road, Higham for Mr. Charles McDermott

The Assistant Director Planning Building Control and Regulatory Services had circulated an update report prior to the meeting which advised that an amended plan altering the layout, comments from United Utilities in relation to drainage and comments from members of the public in relation to the publicity period not yet having expired had since been received. The recommendation to delegate grant consent remained but was now subject to the expiry of the publicity period.

RESOLVED

That determination of this application be **deferred** to the next meeting of this Committee to allow for the expiry of the publicity period.

(b) Planning Appeals

The Assistant Director Planning, Building Control and Regulatory Services reported, for information, that there was one outstanding appeal:

23/0775/FUL 24/0007/AP/REFUSE Appeal against refusal of planning permission for erection of an agricultural building at Land to the South of Heights House, Heights Lane, Fence, Burnley

82. ENFORCEMENT ACTION

The Head of Legal and Democratic Services submitted a report, for information, giving the up-to-date position on prosecutions.

In a verbal update it was reported that evidence that the shipping containers at Moorcock House, Gisburn Road, Blacko (Case 5) might have in situ for over 4 years had since been provided. The content of the Enforcement Notice would now have to be reconsidered due to potential immunity.

A general update on enforcement action was requested. The Council only had one Enforcement Officer who was doing a very good job within available resources. The Officer was serving more Notices and being more proactive and this was assisting with negotiations with householders and developers. It was not known at this stage whether more Officer resource would be made available.

83. AREA COMMITTEE BUDGET 2024/25

The Head of Housing and Environmental Health submitted a report which advised Members on the Committee's 2024/25 Budget.

Members were asked to consider a bid from Blacko Parish Council for £1,265 for New Allotment Fencing. As Members were aware that the Recreational Grounds Improvements Scheme (Scheme no.11, Appendix 1) would not be completed in 2024/25, they determined to make a deallocation of £1,265 from that Scheme in order to be in a position to approve the bid for the New Allotment Fencing.

RESOLVED

- (1) That the Budget as committed and shown in Appendix 1 attached to the report be noted.
- (2) That the Head of Housing and Environmental Health be requested to deallocate £1,265 from the Recreational Grounds Improvements Scheme (Scheme no.11, Appendix 1).
- (3) That the Head of Housing and Environmental Health be requested to allocate £1,265 to Blacko Parish Council for New Allotment Fencing.
- (4) That the financial requirements stipulated in paragraph 4 of the report be noted.

REASONS

- (1) To enable the Budget to be allocated effectively.
- (2) The Recreational Grounds Improvements Scheme would not be completed in 2024/25 whereas the New Allotment Fencing project would.

84. TRAFFIC LIAISON MEETING

The minutes of the Pendle Traffic Liaison Meeting held on 3rd September, 2024 were submitted for information.

It was reported that there was an issue with parked vehicles blocking roads in the vicinity of Spring Mill Court, Fence due to inadequate parking at the development. This would be raised with Lancashire County Council Highways.

85. HIGHWAYS/TRAFFIC ISSUES ON CHURCH STREET, BARROWFORD

Members noted that Lancashire County Council were aware of the concerns raised by the residents who attended the last meeting of this Committee and were currently considering if there were any effective measures that could be implemented. The matter would be discussed further at the next Pendle Traffic Liaison meeting which was expected to take place in late November 2024.

86. PROVISION OF LITTER/DOG WASTE BINS AND SUBSTATION SITES

(a) New Bins

An allocation of £1,000 from this Committee's Budget 2024/25 was approved at a previous meeting on 5th June, 2024. A further allocation of £311 from this Committee's Budget 2024/25 was then approved at the last meeting and three new bins had since been erected during Quarter 2 for the period 1st July, 2024 to 30th September, 2024, as follows:

The total spend was £978.36 which left a balance of £6.52.

(b) Replaced/Removed Bins

The Assistant Director Operational Services advised that due to wear, damage or a reduced need for the facility, one bin had been replaced / removed by Operational Services in Quarter 2 for the period 1st July, 2024 to 30th September, 2024, as follows:

(c) Substation Sites

Members of the Committee were encouraged to report if there were any substations within their area that might need tidying up. Members were asked to provide location details of any substations that were causing a problem with litter and/or fly tipping to Operational Services.

87. FLOODING ISSUES/RISKS

The following updates were reported for information.

Flooding Issue on Wheatley Lane Road, Barrowford

Lancashire County Council's (LCC's) Cyclic Gully cleaning schedule had been checked and all the gullies on Wheatley Lane Road, Barrowford were due to be cleaned imminently.

Should there be a repeat of the issue following this scheduled cleaning LCC should be made aware of it via either the Love Clean Streets webpage (https://www.lancashire.gov.uk/roads-

<u>parking-and-travel/report-it/flooding-and-drainage/</u>) or app (<u>https://www.lancashire.gov.uk/roads-parking-and-travel/report-it/report-it-on-the-go/</u>).

It was reported that there was also a need for the gullies on Wheatley Lane Road, Fence to be cleaned as water was running onto the A6068 during heavy rainfall events. LCC would be made aware of this. County Councillor H. Hartley would also raise this issue when he next visited County Hall.

Drainage Issue outside Bay Horse Pub, Roughlee

An Officer from Pendle Borough Council's Commercial Environmental Health Team was currently investigating this issue and would report their findings at a future meeting.

RESOLVED

- (1) That the updates be noted.
- (2) That Lancashire County Council be requested to clean the blocked gullies on Wheatley Lane Road, Fence.

REASON

To reduce the risk of flooding in the Barrowford and Western Parishes area.

The Assistant Director Operational Services submitted a report on Environmental Crime in the Barrowford and Western Parishes area in Quarter 2, for the period 1st July to 30th September, 2024, along with the totals for 2024/25, which was noted.
