#### 67. GENERAL FUND REVENUE AND CAPITAL BUDGETS 2025/26 AND MEDIUM TERM FINANCIAL FORECAST (2025/26 TO 2027/28)

The Director of Resources submitted a report which proposed General Fund Revenue and Capital budgets, and other related matters for 2025/26 and considered the Medium-Term Financial Forecast for 2025/26 to 2027/28.

Attached at Appendices A, B and C respectively to the report were details of reserves; service level budgets; and capital programme.

Members were advised to take this report into account when making decisions on the 2025/26 budget and associated level of Council Tax. Statements from the Director of Resources (as the Council's Section 151 Officer) were set out in the report.

Councillor D. Whipp introduced and put forward the Liberal Democrat group's budget proposals.

Councillor N. Ahmed introduced and put forward the Conservative group's budget proposals.

Councillor A. Mahmood introduced and put forward the Independent Group's budget proposals.

(The meeting was adjourned at 9.15pm and reconvened at 9.35pm).

Upon the resumption of the meeting, Councillor D. Whipp announced two of the political groups had come to an agreement and moved an amendment to the Liberal Democrat budget motion proposed as follows:

It was moved by Councillor D. Whipp and seconded by Councillor A. Mahmood

> To remove the waste transfer station: £2.21m for that project in the Capital Programme;

The £2.21m to be allocated as follows:

- > For Compulsory Purchase Orders (CPO) for empty properties/homes £600k;
- > For works in the public realm, Barnoldswick, Brieffield and Earby £210k;
- Additional Investment in Leisure Facilities and energy savings and other improvements -£750k;
- Feasibility Study and Design work on a crematorium £100k;
- Asset Transfer Investments £300k;
- > Investment in Bio-Diversity net gain, Marsden Golf Course/Gibb Hill £250k

In terms of the Liberal Democrat revenue budget, it was as stated in the circulated in the budget proposals with the addition of £50k for the apprenticeship scheme and £100k for the Community Sports Funding and the removal of increased cemetery fees increase of £37k.

Councillor A. Mahmood' seconded the motion also moved a further £30k be included towards the Save our Lives campaign. Councillor D Whipp further responded that this element had not been agreed to by his group and that Nelson and Brierfield Area Committee should fund this local campaign.

(The meeting was adjourned at 9.55pm and reconvened at 10.05pm).

Upon the resumption of the meeting, Councillor D. Whipp put forward a further proposal that if the £30k towards the Save Lives campaign was to be included then the £37k towards increased cemetery fees be also included. This was not accepted and Councillor A. Mahmood withdrew his seconding of the motion.

# **REASONS FOR RECOMMENDATIONS**

(1) The Council's current chief executive, who is also the Council's Head of Paid Service, Returning Officer and Electoral Registration Officer, resigned in December 2024 and is due to leave the Council towards the end of March 2025. Following her resignation, the Council has commenced the search for a new chief executive. The recruitment process will take serval months, so an experienced interim chief executive is required; and

(2) The recommendations ensure interim arrangements are in place to secure leadership and designation of the statutory roles during the period between the departure of the current chief executive and commencement of the employment of the new postholder.
