7. <u>Area Committee Budget</u>

Allocation for 2024/25

The Director of Place reports that the Area Committee's budget for 2024/25 was £31,490 – plus £101 brought forward from 2022/23 - and has all been allocated.

£16,323.96 has not yet been spent and will be carried forward into 2025/26 although this figure may change slightly before the end of the financial year. It includes the following schemes:

Litter and dog waste bins (Barnoldswick & Earby) - £1,212.01

Street nameplates (Barnoldswick & Earby) - £731.60
Premises Improvement Grants (Barnoldswick and Earby) - £11,270.83
Footpath improvements to Barnoldswick Church Primary School - £500.00
Consideration of the Governments FFAP for Earby - £300.00
Maintenance of Sough Park - £2,309.52

Total - £16,323.96
