DECLARATION OF INTERESTS

Members were reminded of the legal requirements concerning the declaration of interests. There were no Declarations of Interest.

5.

PUBLIC QUESTION TIME

A resident of Higham, who had attended the previous five meetings to speak about the same matter, was in attendance again as the fence on some land in Higham still continued to cause a serious hazard for vehicles entering the A6068 owing to visibility splay obstruction. The resident enquired as to whether there had been a positive response from owner of the land to the Assistant Director Planning, Building Control and Regulatory Services' request for the offending section of side fencing on their land to be removed. The Planning Officer confirmed there had not been.

The Chair apologised to the resident for having to attend five meetings to speak on the same matter and said the next steps would now be determined. The Chair felt the most appropriate course of action was to request that the Assistant Director Planning, Building Control and Regulatory Services submitted a full report to the next meeting of this Committee to set out the current legal position and the enforcement actions that could be taken in this particular case.

Another resident of Higham raised further issues associated with the same piece of land which they felt should be considered alongside the fencing issue and not in isolation as they had been.

The Chair said the Assistant Director Planning, Building Control and Regulatory Services would be asked to also address the further issues in the report they would be submitting to the next meeting.

A resident of Parrock Road, Barrowford raised health and safety concerns over the height of a wall on the road. The wall was currently 1.6m with a topping stone still to be added and the conditions attached to the original approved planning permission (21/0758/FUL) stated a height of 0.9m. There had already been numerous near misses due to the blind spots and visibility

issues caused by the height of the wall. This issue had already been raised with the Planning Enforcement Officer and further updates were awaited.

The resident also reported that WiFi and telephone connection issues were being caused for the fourth time by the approved development on the road.

Members said they would discuss the issues with the Assistant Director Planning, Building Control and Regulatory Services and asked the resident to provide further details following this meeting to inform that discussion.

RESOLVED

- (1) That the Assistant Director Planning, Building Control and Regulatory Services be requested to submit a full report to the next meeting of this Committee to set out the current legal position and the enforcement actions that could be taken against the owner of the land in question in Higham.
- (2) That the further issues raised by the second resident of Higham also be addressed in the report referred to in (1).
- (3) That discussions, informed by the details to be provided by the resident of Parrock Road, Barrowford following this meeting, be held between Members of this Committee and the Assistant Director Planning, Building Control and Regulatory Services.

The crime figures for April were showing no increase with the exception of Burglary – Other than Dwelling, Assaults and Anti-Social Behaviour (ASB). There had been a 53% increase in the number of reported ASB incidents. PCSO L. Marsden explained that the spike in ASB was mainly e-bike and scooter related.

The Police's plans for dealing with speeding vehicles as the summer months and longer, lighter nights approached were enquired about. PCSO L. Marsden said the Police would be running Operation Nemesis for the second time to tackle all aspects of anti-social driving. He added that the operation would focus on issues within the Barrowford and Western Parishes area.

PCSO L. Marsden said Members and residents of the Committee area could register for 'In the Know' to receive regular alerts and updates from the Police (<u>https://www.lancashire.police.uk/contact-us/in-the-know/</u>). He further urged those present to remain vigilant and to report any concerns either via 101 or 999 in the case of an emergency.

8. PLANNING APPLICATIONS

(a) Planning application for determination

The Assistant Director Planning, Building Control and Regulatory Services submitted the following planning application for determination: -

11. TRAFFIC LIAISON MEETING

The minutes of the Pendle Traffic Liaison Meeting (PTLM) held on 26th February, 2025 were submitted for information.

Members noted Item 4.2 – Cross Lane, Barley – DYL extension request in particular and were encouraged that additional inspections had been agreed and that there would be further discussion on the matter at the next PTLM.

Members felt that opportunities might have been missed previously by not referring issues to the PTLM and said they would use the mechanism more going forward.

12. PREMISES IMPROVEMENT GRANT SCHEME – SUMMARY 2024/25

The Head of Economic Growth submitted a report to request that Members agree to a funding allocation of £3,000 for 2025/26 and also consider the appointment of two Grant Panel Members for the year. Consideration of this report had been deferred from the last meeting of this Committee.

It was reported that the issues had already been referred to Lancashire County Council Highways and also to United Utilities and were under investigation. An update would be provided at a future meeting.
