Meeting on site with owner and Parish 14/12/23. Agreed programme of clearance to be completed before the February 2024 Area Committee meeting.  Hearing listed on 2 <sup>nd</sup> October 2024 for non-compliance. Didn't turn up at Court so arrest warrant issued.  Pleaded not guilty – trial set for 29 <sup>th</sup> July 2025

Heights House, Heights Lane, Fence			20/11/22	03/01/23	03/02/23	served requiring the owner to permanently remove the caravan from the land and cease using the land for non-agricultural purposes and to remove all the hardstanding and sub base material and reinstate the grassed field and wall to its former condition.  Appeal dismissed.  The defendant pleaded guilty in court on 22nd May 2024 and was fined.  Further work undertaken which needs to be checked on site for compliance. Planning to check.  Needs another visit. No response to the request for a site visit.

Not guilty plea. Trial 19th March 2025. Prosecution withdrawn due to legal issues.  Further Enforcement Notice served 16th May 2025.
